age 33 years resident of Bhuttabori PO & PS Bagdogra
Dist Darjeeling like to inform you that on 10-03-2025
my husband along with Bijay Burman were coming to
Bhuttabori through Siliguri Kolkata Highway (NH) by riding
his motor cycle bearing No. WB74BP 1065 when they
reached near Bagdogra Airport diversion at about 11:00 am
at that time one Ambulance bearing No. WB73E 5912 coming
from opposite direction enter into the wrong side at
high speed being driven rash and negligent manner hit
my husband motor cycle. As a result of which both were
sustained injured and immediately shifted to North Bengal
Medical collage and Hospital where my husband was de-
clared dead and Bijay Burman was admitted there.
I am shocked premature death of my husband and I
was busy in funeral work, so I am lodging this FIR
today.

I therefore request you to kindly take
necessary steps against the driver of offending
vehicle bearing No. WB73E 5912 as per law.
