I, Sweety Barmo D/o Manoranjan Barmo resident of Gadadhar Pally, Upper Bagdogra, P.S – Bagdogra, Dist – Darjeeling, PIN – 734014 do hereby bring to your kind attention that on 15/03/2025 at about 07:00 pm my father Mr. Manoranjan Barmo S/o Late Amlya Ratan Barmo aged about 55 years, was walking from our house towards Panighatta More side by the left flank of the road. At that time one Motor Cycle bearing registration number WB74BU1920 which came from behind at a very high speed and in a rash and negligent manner dashed my father from front back side. As a result he immediately fell down on the concrete road and sustained serious injuries to his person. Thereafter local people shifted my father to the Galaxy Hospital, Bagdogra where the attending doctor referred him for better treatment, thereafter we shifted him to Ncotia Getwel, Hospital Siliguri where currently he is undergoing treatment.

The accident took place due to rash and negligent on the part of the driver of the said Motor cycle bearing number WB74BU1920. Therefore, it is my humble prayer to you that investigate the matter and take necessary action against the said offending vehicle for the ends of justice and oblige.
