Sir,

In producing herewith the following accused person namely Sunil Oraon (25 yrs) S/O Asaru Oraon of Simulguri, Middle Palash, PS- Pradhan nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) One Truck bearing Registration Number WGY/4674 loaded with River bed materials approx 100 cft under proper seizure list. I, SI Biswajit Biswas of Pradhan Nagar P.S, SPC do hereby lodge this Complaint against the the above noted arrested accused person namely Sunil Oraon (25 yrs) S/O Asaru Oraon of Simulguri, Middle Palash, PS- Pradhan nagar, Dist. Darjeeling and the owner of the said seized vehicle having Registrtrtion number WGY/4674 to the effect that on 19.03.25 at 22.05 hrs onwards I was engaged to perform RT Mobile van duty vide GDE No 1170 dated 19.03.24 and MCC No 510/25 dated 19.03.25. In course of my RT Mobile van duty at around 06.45 hrs on 20.03.25 I received a specific source information that one truck bearing Reg. No. WGY/4674 loaded with illegal River bed materials was coming towards Circuit House More side from Mahananda river Bed, under PS- Pradhan Nagar, Dist.- Darjeeling without any valid documents. Accordingly, I informed the fact to you over mobile phone and as per your kind order and direction myself along with force had been to Circuit House More under PS- Pradhan Nagar, Dist.- Darjeeling. At around 07.15 hrs we detained the said truck displaying number plate WGY/4674 loaded with illegal River bed materials at near Circuit House under PS- Pradhan Nagar, Dist.- Darjeeling and also found that the driver was inside the cabin of the said truck. On being asked he disclosed his name and identity as noted above. On demand he failed to produce any documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he with the help of his owner mines such river bed materials from Mahanda River by illegal means with a view to sell the same to their design customers for their illegal gain. Accordingly, I seized the above noted vehicle having registration number WGY/4674 leaded with illegally mining river bed materials under proper seizure list and subsequently arrested him after maintaining all formalities of arrest and brought to Pradhan Nagar PS for further investigation. The search and seizure was made in between 07.25 hrs to 07.35 hrs. at the spot under the coverage of videography.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Sunil Oraon (25 yrs) S/O Asaru Oraon of Simulguri, Middle Palash, PS- Pradhan nagar, Dist. Darjeeling and the owner of the said seized vehicle and arrange for its investigation.
