Sir,

In producing herewith the following accused person namely Bipul Oraon (28 yrs) S/O Late Balkan Oraon of South Palash, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) One Tata Truck having registration number WGY/7116 loaded with illegal River bed materials under proper seizure list. I, ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodge this complaint against the the above noted arrested accused person namely Bipul Oraon (28 yrs) S/O Late Balkan Oraon of South Palash, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling and the owner of the said seized vehicle to the effect that on 20.03.25 at 06.35 hrs I received a secret source information that one Truck having registration WGY/7116 loaded illegal river materials from Mahananda river bed and proceeding towards Champasari via Champasari Road under PS- Pradhan Nagar, Dist. Darjeeling. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 1179 dated 20.03.25 and informed the fact to you over mobile phone and as per your kind order and direction myself along with force had been to Champasari main road. At around 07.45 hrs we detained the said truck displaying number plate WGY/7116 loaded with illegal River bed materials at Champasari main Road near Champasari Anchal under PS- Pradhan Nagar, Dist.- Darjeeling and also found that the driver was inside the cabin of the said truck. On being asked he disclosed his name and identity as noted above. On demand he failed to produce any valid documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he with the help of his owner mines such river bed materials from Mahanda River by illegal means with a view to sell the same to their design customers for their illegal gain. Accordingly, I seized the above noted vehicle having registration number WGY/7116 loaded with illegally mining river bed materials under proper seizure list and subsequently arrested him after maintaining all formalities of arrest and brought to Pradhan Nagar PS for further investigation. The search and seizure was made in between 07.55 to 08.15 hrs. at the spot under the coverage of videography.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Bipul Oraon (28 yrs) S/O Late Balkan Oraon of South Palash, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling and the owner of the said seized vehicle and arrange for its investigation.
