In producing herewith one without number plate Euro 47E 16 Tractor loaded with River Bed materials/sand having chassis No-T053687634LN & Engine No-E3784457 under proper seizure.

I beg to report that, I ASI Dipak Karmakar s/o Dulal Karmakar of Bhaktinagar Police station under Siliguri Police Commissionerate lodge a written complaint against the owner with the above noted vehicle to the effect that today i.e. 19.03.25 at 04.00hrs as per source information Myself along with SI Yuel Lepcha, SI Srimanta Chatterjee, ASI Ramesh Bitrikuti, C/374 Debraj Biswas all of Bhaktinagar PS had been to North Bengal more, near Vega circle mall under Bhaktinagar PS (vide Bhaktinagar PS GDE No-1009 dated 19.03.25) and found above noted vehicle loaded with illegal river bed materials/sand was coming from Salugara side towards Check post side through Sevoke road under Bhaktinagar PS. On chasing we apprehended the above noted vehicle but the driver fled away from the spot. On checking the vehicle and found loaded with river bed materials/sand. Further, hence there was reason to believe that the driver of above noted vehicle had procured the loaded river bed materials/sand illegally and transporting the same for his illegal gain from Mahananda River without any valid documents/Licence in respect of vehicle or river bed materials/sand.

On further grilling he procured the river bed materials/sand illegally from Mahananda River bed and carrying/transporting the same to Salugara side from river bed for his wrongful gain without any valid documents. Under the circumstances, I seized the above noted vehicle along with loaded river bed materials/sand under proper seizure list in presence of witnesses and the driver of the vehicle fled away from the spot. The whole process of search, seizure took place in between 05.05hrs to 05.15hrs with proper audio & VDO grappled.

Under the above, I pray before your kind end to start a case against the owner/driver of the seized vehicle under proper section of law and caused its investigation.
