Sir,

In producing herewith the 01 (one) arrested accused person namely (i) Chiranjit Barman @ Prasenjit Barman @ Chiru (27) s/o Sushil Barman of Binooy More, Housing Ground, PS-New Jalpaiguri, Dist.- Jalpaiguri permanent address Gandupuri, PS-Mathabanga, Dist.-Coochbehar along with the following seized articles under proper seizure list. The Ground of arrest is duly communicate with him in writing:-

- (i) 01 (One) Packet containing 285 gram of suspect to be brown sugar kept in Black carry bag marked as "Exhibit-A".
- (ii) One dark green color 1+ Mobile Phone having Sim No.- 959339235 having IMEI No.- 861797073537572 (ii) 861797073537564.

I, SI-Pradeep Diyal of Asigarh OP, under Bhaktinagar PS, Siliguri Police Commissionerate do here by lodge this written complaint against above noted arrested accused person to the effect that today 19.03.2025 at about 1615 hrs I received a specific source input that one person would be coming to Tharugahti Picnic Eco Sport, under Bhaktinagar PS, Dist.- Jalpaiguri with huge with huge quantity of Brown Sugar for delivering the same to his designed customers. The matter was diarized vide Asigarh OP GDE No.-576 Dt. 19.03.2025 and I informed the matter to O/C, Asigarh OP, under Bhaktinagar PS in writing a letter to him and expressed the entire information. As per their kind direction, myself along with other officers and force named ASI Prasenjit Barman, ASI Dinesh Chandra Roy, C/134 Ginen Basumata all are of Asigarh OP, under Bhaktinagar PS, SPC being headed by me left for Tharughati Eco Picnic Spot, under Bhaktinagar PS, Dist.-Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide Asigarh OP GDE No.-580 dated 19.03.2025 and M.C.C. No. 210/25 dated 19.03.2025. In the meantime I also informed the Videographer namely Bittu Majumdar (23) s/o Ananda Majumdar of Telipara, PS-Bhaktinagar, Dist.- Jalpaiguri to be present at Tharughati Eco Picnic Spot, Tharughati, PS-Bhaktinagar, Dist.- Jalpaiguri to prepare the Video of whole process of search and seizure if any as well as informed Mobile Van officer namely ASI Hasibul Hoque who is detailed for Mobile Van duty vide Asigarh OP MCC No.-209/25 date: 19.03.2025 to accompany us during the whole process of search and seizure if any. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence of facility for the escape of the offenders. At about 1655 hrs we arrived at Tharugahti Eco Picnic Sport, Tharughati, PS-Bhaktinagar, Dist.- Jalpaiguri and on the way to the spot at Tharughati Eco Picnic Spot I called two independent witnesses namely (i) Bikash Biwas (36) s/o Lt. Sunil Biswas of Asigarh Colony, Ghoghmal, PS-Bhaktinagar, Dist.- Jalpaiguri (ii) Bablu Roy (32) s/o Sarad Roy of Telipara, Naresh More, PS- Bhaktinagar, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if any. Accordingly I, served Notice with a written letter and necessary permission of his presence and act as Independent witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that 01 (One) person is waiting for someone in front of Tharughati Eco Picnic Spot, Tharughati, PS-Bhaktinagar, Dist.- Jalpaiguri which was matched with our information. Accordingly, we apprehended him and disclosed our identity.

After disclosing our identity, we detained the above noted person with a strong reason to believe that he illegally possessing Brown Sugar and selling the same to his designed customers for his wrongful gain. On being asked he confessed the he possessed Brown Sugar [narcotics substances]. I then gave him an option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Police Gazetted Officer. Then he agreed to be searched by Police Gazetted Officer. Further, I served them notice in accordance with provisions of law in this regard. I also offered the independent witnesses and the apprehended person to search our Police Party as per provision of law but he refused to search the police party. Accordingly, I informed the matter to the Officer-In-Charge, Asigarh OP, under Bhaktinagar PS, SPC and as per their kind order I informed the fact to Shri Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, SPC and request him to acting as Special Executive Magistrate as per order of superior regarding the interception of the accused person suspected to be possessed of Brown Sugar in his

possession and requested him to come to the spot and to supervise the search and seizure being a gazetted officer. Accordingly at 1735hrs Sri Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, Siliguri Police Commissionerate arrived at the spot then I, disclosed his identity to the detained person as Special Executive Magistrate.

Then in presence of Sri Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, SPC act as Special Executive Magistrate and two independent public witnesses, we searched the detained person following all formalities and recovered (i) 01 (One) Packet containing 285 gram of suspect to be brown sugar kept in Black carry bag (ii) One dark green color 1+ Mobile Phone having Sim No.- 959339235 having IMEI No.- 861797073537572 (ii) 861797073537564. Kept in right pocket of pant

Thereafter, in presence of Sri Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, SPC and independent witnesses I seized the recovered articles i.e (i) 01 (One) Packet containing 285 gram of suspect to be brown sugar kept in Black carry bag marked as "Exhibit-A" (ii) One dark green color 1+ Mobile Phone having Sim No.- 959339235 having IMEI No.- 861797073537572 (ii) 861797073537564 at the spot in front of Tharughati Eco Picnic Spot under proper seizure list in presence of Executive Magistrate Sri Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, SPC and as well as independent witnesses as noted above and acknowledged by the accused person. Subsequently, I labelled the seized articles in presence of Sri Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, SPC and independent witnesses and accused person as noted above. The whole process of seizure was made in between 1745 to 1815 hrs on 19.03.2025 under proper videography prepared by Bittu Majumdar. On further asked he confessed in presence of Sri Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, SPC acting as Special Executive Magistrate and other witnesses that he procured Brown Sugar clandestinely from Khoribari area and came to Asigarh area for the purpose of supply the same to his designed customers as per their requirement for his personal gain by illegal means. On interrogation he also disclosed that he has been dealing in such business of selling Brown Sugar illegally for the last few months

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Chiranjit Barman @ Prasenjit Barman @ Chiru (27) s/o Sushil Barman of Binoy More, Housing Ground, PS-New Jalpaiguri, Dist.-Jalpaiguri permanent address Gandupuri, PS-Mathabanga, Dist.- Coochbehar are involved in procuring and selling of Brown Sugar illegally and contravening the norms of NDPS Act was established. Then, I arrested the above noted accused person after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of seizure, labelled and arrest was made in-between 1745 hrs to 1818 hrs on 19.03.2025 under proper videography.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the above noted arrested accused persons namely Chiranjit Barman @ Prasenjit Barman @ Chiru (27) s/o Sushil Barman of Binoy More, Housing Ground, PS-New Jalpaiguri, Dist.-Jalpaiguri permanent address Gandupuri, PS-Mathabanga, Dist.- Coochbehar (Not verified) and arranged for its investigation.
