Dear Sir:

I, Lalit Kumar Agarwal, S/O Late Moman Ram Agarwal proprietor of M/s Shiv Plywood Centre situated at Sevoke Road, Opp. Nanak Tower, Sevoke Road, Siliguri beg to state as follows:

- 1) That I have a godown (L/30) at Mittal Compound, Sevoke Road, Opp. Anandloke Hospital, Siliguri for storing Plywood.
- 2) That on morning of 15th of this month someone informed me that shutter of my godown is broke open. I rushed to the godown and found the shutter broke open.
- 3) That I entered the godown and found that approx 100 pcs Plywood sheets were stolen.
- 4) That I checked the CC TV footage of the area and found that 2 (two) Tata pickup vehicle entered the compound at 11.00 p.m. on 14th night and left the premises with loaded stock of stolen plywood at 01.21 a.m. on the same night.

I, therefore, request you to kindly lodge this FIR and do the needful for recovery of the stock and book the culprit as per law.
