SUB- Written Complaint against Sanjoy Das, S/o Late Ganesh Das, of Naresh Villa, Near Samar Biri Factory, Aurobindapally Main Road, P.O Rabindra Sarani, Dist.- Darjeeling.

Respected Sir,

I Smt. Sangita Das, W/o Late Alok Kumar Das, resident of Malbazar, would like to like draw your kind attention to the following effect that my elder daughter namely Deborita Das now deceased was married with aforesaid person namely Sanjoy Das, U/s- 27 of Special Marriage Act, on 05.07.2016 before the marriage officer of Dist.- Jalpaiguri, Vide Reg- sl. No 71/2016, after the said registration of marriage there was one reception which was held up on the eve of aforesaid marriage on 15.08.2016 at Rabindra Sangha Club, P.O. & P.S. Siliguri, Dist. Darjeeling, in presence of relatives friends & wellwishers of both parties. That after the marriage my aforesaid elder daughter (now deceased) one flat was purchased at C-1 Naresh Villa, Near Samar Biri Factory, Aurobinda Pally Main Road, P.O. Rabindra Sarani, Dist.- Darjeeling, wherein my said daughter and her husband resided but her husband after few years of marriage started to torture my aforesaid daughter (now deceased) mentally and physically and also pressurized my daughter to hand over the entire salary amount on each & every month to her husband and when my daughter refused to fulfil the demands of my Son-In-Law then he abused her with filthy languages and used to humiliate her in front of her office colleagues and used to taunt her, but my daughter used to digest the said torture of her husband with a hope that everything will be okay in future but all are in vain, however on 19/08/2022 out of their wedlock one male child was born namely Kriyansh Das. The Son-In-Law of my elder daughter never cared of his minor child nor performed any duty being a father of the minor child, on protested against mental torture used to increase day by day upon my daughter (now deceased) and also used to state rather objectify that the minor son is not his own biological son.

It is to be noted that my aforesaid daughter (now deceased) was an employee of Central Govt as Postal Assistant and her husband i.e., my Son-In-Law is also an employee of Central Govt. and working as a Postal Assistant and presently posted at Matigara. That due to prolonged torture ultimately my daughter had lodged a written complaint to the Head Post Office Siliguri on 16/01/2024. The photocopy of the said written complaint is annexed with

this complaint and under such compelling situation my daughter left her husband and took shelter at her parental house at malbazar alongwith her minor son after locking her flat and after 1 /2 days my daughter alongwith with me again entered into my daughters flat and used start to reside there and on 17/01/2024 my daughter (now deceased) filed a divorce petition U/s 27 of the Special Marriage Act before the Ld. Additional District & Session Judge 1st Court at Siliguri against her husband and the said case was registered as Mat Suit No- 22(1) of 2024 and transferred the said case before the Ld. Additional District Judge Fast Track Court at Siliguri and in the said case was posted on 01/02/2025 for reconciliation and it is to be noted that the husband of my daughter (now deceased) also filed written objection in that said case. The photocopy of the order sheets of divorce application, written objection is annexed with this complaint. That after the birth of the minor child Kriyansh Das and I being the a maternal grand mother used to take care of said child and the husband i.e. Son-In-Law of my daughter (now deceased) didn't used to look after the said child moreover the i.e. Son-In-Law used to reside in a rented house at Sevoke Road. It is a matter of regret to state that on 05/12/2024 my daughter (now deceased) met with an accident at near the PNT Colony and thereafter she sustain severe injuries which ultimately resulted in her death / expired. Thereafter we called the husband i.e. Son-In-Law of my daughter for performing the last rituals of my daughter but wherein the husband i.e. Son-In-Law of my daughter created hue and cry and mentally assaulted us by using unparliamentary languages and asking for the documents and service related all papers for taking death claim and other benefits alongwith with the minor child of my elder daughter (now deceased) but we agreed to give everything except the minor son as because the said son not attached with his father and there is no person in his rented house to look after the said minor child and if the said child was taken by his father i.e., i.e. my Son-In-Law my then the minor child would became the patient of trauma as recently he lost his mother and at present he is attached with his maternal me and with his maternal uncle and we are very much stable financially to give him (minor child) proper food, medical, clothing, shelter, education, time for upbringing the said minor child. Presently the husband of my said daughter (now deceased) used to threatened us by saying that he will lodge a kidnap case against us.

It is pertinent to mention that the apart from all these acts of activities of my daughter husband my elder daughter husband was planning a conspiracy against my elder daughter [now deceased] as because my elder daughter had a govt service and if my daughter expires at an early age then the entire death benefit claim will be in his hands. Therefore, it is my deep feeling that the unnatural death of my daughter was a pre-planned plotted guilty and malafied intention of my Son-In-Law. Moreover, it is pertinent to mention that soon after the death of my elder daughter, the said Son-In-Law

immediately filed a MACC CASE before the Ld. A.D.J. 1st Court at Islampur bearing Filing Number 34/2025 for recovering the death claim from the insurance company, but it is ironic to state that the party who has been impleaded as an O.P. of offending vehicle is not the actual vehicle who had hit my daughter and killed her, the actual offending vehicle is of a different colour and was been driven by a different offender which was red in colour, which recently came to our knowledge from CCTV Footage. Therefore, it's my deepest feeling that the said death of my daughter was a pre-planned murder by my Son-In-Law.

 The CCTV footage of the said accident is saved herein in this Pen Drive herein marked as Annexure: A.

That it is pertinent to state that my Son-In-Law while having a dispute with us at the time of handing over the related paper of service of my deceased daughter then my i.e. Son-In-Law himself confessed that yes, he has committed the act of murder of my elder daughter now deceased and the said conversation was also recorded in my son cell phone through videography dated on 22.12.2024. Moreover, it is pertinent to mention that the said Son-In-Law of mine went a step further and had ransacked the apartment of my deceased daughter wherein he had broken the pad lock and had stolen all the gold ornaments of her marriage along with my ornaments, cash amount and all-important documents of my deceased daughter dated on 29.12.2024.

That some unintentional delay had occurred as because my mental sate was not at all stable as because I recently lost my daughter at a very young age.

In view of the above and considering the aforesaid incident you are requested to take proper legal action as per law.
