Sir,

With due respect and humble submission, I ASI Dipak Kr. Chhetri of Matigara P.S do hereby lodge this written complaint to the effect that on 21/23-03-2025 I was deputed to perform K-33 Night Mobile Van duty along with force, since 22:00 hrs to 08.00 Hrs (22.03.25) vide Matigara P.S. C.C. No. 49/2025, Dated - 21/03/2025 and Matigara P.S. GDE No. 1234/25, Dated - 21/03/2025 in course of said van duty I received source information that 01 (One) vehicle Tractor green colour bearing Regn. No. WB 73 F 1239 is plying at Baniyakhari near Hanuman Mandir under Matigara PS area loaded with river bed materials which was procured clandestinely. On received such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed at Baniyakhari under P.S.- Matigara and found the above noted vehicle loaded with river bed materials standing at Baniyakhari near hanuman mandir. On seeing the Police team the driver of the vehicle managed to flee away from the spot to leaving the vehicle abandoned. It is crystal clear that the driver/owner of the vehicle Tractor green colour bearing Regn. No. WB 73 F 1239 procured the loaded river bed materials from somewhere clandestinely and was proceeding to sale the same to his designated customer for his wrongful gain. I tried hard to trace out the driver / Owner of the vehicle but in vain nobody came forward to claim the vehicle.

Finding no other alternatives, I seized the vehicle Tractor Green colour bearing Regn. No. WB 73 F 1239 loaded with river bed materials (sand) under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S. The whole process of seizure was made in between 06:01 hrs to 06:21 hrs. Dated, 22.03.2025.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver / owner of the seized vehicle Tractor green colour bearing Regn. No. WB 73 F 1239 and arrange for its investigation.
