Chennai for treatment.

I, Pritam Sen, care of pantha sen residing at, Kanchan
Jungla Stadium, Railway Quarter near bidhan road,
opposite of press club, quarter number-E/237/1, would
like to formally report a case of theft at my residence.
I had travelled to Chennai for medical treatment for
one month, and during my absence, unknown individuals
unlawfully entered my house and stole various
valuable items.

Details of the Theft:

- Date of Theft - Between 14/02/25 to 21/03/25 (During my absence)
- Location - Kanchan Jungla stadium, railway quarter near bidhan road.
- Description of stolen items :-
 - Electronics & Appliances - 3 ceiling fan, 1 stand fan, 2 induction cook-tops, 2 mixer grinders, 1 refrigerator, 1 LED TV, 1 iron.
 - Cash & Documents - ₹15,000 cash, ATM card & bank pass book.
 - Household Items - Three trunk of bronze utensils, ~~2~~ Steel utensils, 2 gas cylinders. Other items - Brass sculpture of Lord Bajrangbali and ganesha, 1 Tullu pump, clothes.

Recent Incident - On March 21, 2025 a thief tried to break
in my house. I immediately informed the police, and the
suspect was taken in custody.
