Therein, I noticed that the official e-mail id of this office igpnbrslg18@gmail.com which is under the domain of Inspector General of Police, North Bengal Region was misused by unauthorized person(s). The said e-mail id was used for purchasing Bitcoin USD 678.99 (58,674.24 Indian Rupee) through PayPal, Trade ID 147527729628.

The misuse of the government e-mail id has caused unauthorized access to sensitive government data without permission.

It appears that the unknown suspect(s) has misused government e-mail and impersonated to purchase bitcoins for unlawful gain, which requires a detailed investigation in the matter.

Therefore, I request you to register the FIR and take appropriate action against the unknown suspect(s) under the relevant sections of law.
