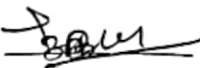

On 21.03.25, a specific information was given by FGT SHQ Siliguri regarding the movement of On Foot carrying cattle heads without valid documents from Matigaraha Market towards Dangrapara. The Next Day They Were Supposed To Take It To Belakhoba Market. Getting The Information A Special Mep Has Been Planned And Laid At Around 210545 By Asi Yogendre Kumar Party Commander Along With And 03 Ors Of 46 Bn Bsf And A S Bhoi A/W 02 So And 02 Ors Of 18 Bn Bsf (Including Unit 'G' Rep). The On Nh- 27 Near Mahananda Cannal, Fulbari. At Around 210605 Hrs The Party Observed Movement Of The suspected On Foot Which Was Coming From The Mahananda Cannal Side. The Mep Party stopped The Suspected. The Party Asked Them To Produce Necessary Documents Of Cattle But He Failed To Produce The Proper Documents. Accordingly, The Party seized 10 NOS of illegal Origin Suspected To Be Smuggled Through Ib And The Cattle Handelers Also Revealed that These 10 Cattle's Belong To Person Namely Jalil S/O Hamidur Haq, Age 52 Years Appx, Mob No 9832615837 Of Village Dangapara. The also apprehended 03 Indian nationals with 03 mobile phones (Android) and Indian currency Rs 20/-. PQR is in progress and after legal formalities apprehended 03 Indian nationals along with seized items will be handed over to NJP police station.

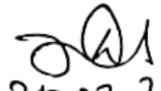
