I would like to bring to your notice that yesterday i.e 22/03/2025 at around 7.30 am ,some miscreants namely, Dilip Barman S/O Debendra Nath Barman permanent resident of Kadam Gach, Naya Basti Champa Sari, Uma Shankar yadav, S/O Kailash Yadav, residing at Narmada Bagan, Binod Yadav S/O Lilu Yadav, resident of regulated market TC11/HK, Shivnarayan Yadav alias Bantha Yadav, S/O Late Sri lal Yadav resident of Regulated Market, TC3/ 1BOS, Lilo Yadav, S/O Raghuni Yadav, resident of regulated market TC/11 HK, Rampukar Yadav S/O Late Dhukhan yadav resident of Pokaijote ward no. 46, , Sanjib Roy, Sharif Chand Yadav (Father & address unknown), Rupesh Yadav S/O Lilu Yadav residing at TC11/HK with others attacked with iron rod, hockey sticks, hooks and other assaulting weapons, forcefully entered into stall/ Gaddi no.TB 01 of Regulated Market, Siliguri and threatened to employ labours (all resident of other states) or to give a ransome of Rs. 150000, for the job which they have bought from Mr Bhaddu Shah, resident of Darbhanga, District, Bihar who has already left the work 30 years ago and forcefully takena ransome of Rs. 150000 from me.

Sir, I doubt these named miscreants, would by themselves or others might try to create a ruckus and hamper the peace inside the Regulated Market area, Siliguri for their personal interest and financial benefit. I would like to request you to kindly intervene and take necessary action against the miscreants, to help save the peace of the Regulated Market premises. Looking forward for your kind cooperation.
