It is submitted that,

- 1. I the undersigned, humbly state that I am an Ex-serviceman No 6947614P Ex Nk Raju Kumar Sharma S/o Shri Ram Chandra Sharma residents at Khaprail market. I want to bring to your notice that on 27 & 28 Feb 2025, a fraud has been committed against me on the name of false recruitment in Security Services.
- 2. On 27 & 28 Feb 2025 two individual namely **Mr Mausham Kumar Mob No** (7070829894, 8825208417) and Retire ex-serviceman **Mr Sudhir** Mob No (9547111415) contacted me for recruitment in Security Services and demanding money for that. I gave them one lakh rupees by paying 50,000/- by UPI and 50,000/- in cash. (Few copies enclosed).
- 3. However, on verification, I found that there is no such recruitment has been taken place. Individual has fraudulently collected money from me falsely quoting unit's name at Khaprail Market near unit premises on pretext of offering me job for Security Services. Money was collected via UPI transaction and also in cash from civilians @ Rs 15000/each.
- 4. It is also submitted that, Mr Mausham Kumar & Mr Sudhir also placed a counter near Sharma Studio, Khaprail Market and then at City Centre Mall also at various places to carry out fraudulent enrollment of civilians for security services for financial gains.
- 5. I, No 6947614P Ex Nk Raju Kumar Sharma Mob No (9149739654) approached unit and informed them about the fraud which was being done by both individuals Mr Mausham Kumar and Retire ex-serviceman Mr Sudhir falsely using unit's name. I hereby clarify that there is no unit personnel or any Indian Army personnel involved in this fraud and unit's name has been taken to Malign image of unit and The Indian Army. I, hereby submit copies of UPI money transaction done by me to Mr Mausham Kumar. (Copy attached).
- 6. You are requested to take strict action against fraudsters for refund of money please.
