I, **ROZY PRASAD**, W/O Prasant Prasad, D/O Vijay Bhagat, Resident of Siliguri, Anil Busty Kolai Busty, Near Churangi more, P.O. & P.S. Matigara, District - Darjeeling, Pin-734010, do hereby want to inform you as follows :-

1. That I lodge this F.I.R. to the effect that I **ROZY PRASAD**, W/O Prasant Prasad, D/O Vijay Bhagat was married with **PRASANT PRASAD**, S/O Santosh Prasad, resident of Sang Bazar, P.O. Sang, P.S. Singtam, Dist. Gantok, in the State of Sikkim on 10.02.2012.
2. That during the marriage negotiations, my husband and my father in law namely Santosh Prasad demanded cash dowry of Rs. 2,00,000/- (Rupees Two Lakh only) from my parents, and my father has given the cash dowry of Rs. 2,00,000/- (Rupees Two Lakh only) to my husband and my father in law. Moreover, Godrej Almirah, gold ornaments worth Rs. 2,00,000/- (Rupees Two lakhs only), which has been handed over to my husband and my father in law presence of the other relatives.
3. That soon after marriage my husband and my father in law started to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply their demands my husband, my father-in-law namely **Santosh Prasad**, started to torture me, beat me mercilessly and used abusive languages upon me in respect of my skin complexion.
4. That in this regard I would like to state that our marriage is an arranged marriage which has been arranged by the matrimonial uncle and aunty of my husband respectively namely one **Hari Jaiswal** and his wife namely **Sangeeta Jaiswal** both are resident of Beside the Gali of Malay Chakraborty Nursing Home, S.F Road, P.O & P.S Siliguri, Dist- Darjeeling and it is also to be mentioned here that there is a Ten (10) years age difference between me and my husband but I gave my consent hoping that everything will be taken care by my husband but all my expectations are in vain as my husband always humiliate me before the society and also humiliate me in front of my family members without any realm or reason.
5. That the above named maternal uncle and maternal aunty of my husband used to instigate my husband and my father in law for demanding dowry from my parental house and when I express my inability, the above named persons instigate mine in laws to torture me physically up to that limit so that I will be bound to bring enough dowry as per their demand from my parental house.

6. That in the month of February, 2017 when I was residing with my husband along with my other in-laws, suddenly started comment on my complexion and abuse me in filthy languages without any reasons and when I protested against the same then my husband banged my head on the wall and I lost my sense.
7. That my husband along with his other family members as mentioned above always used to humiliate me in all respect and in spite of fulfilling all their dowry demands my husband was never happy with me and always used to taunt me as I had brought insufficient dowry. I was treated like a servant from the very beginning and not given the status of a wife. I was bearing all the torture of my husband with a hope that everything will be alright in future but everything was in vein.
8. That after that whenever I want to visit to my parental house, my husband and my other in laws forced me to leave my matrimonial house permanently and my husband continuously threatened me that if I refuse to go to my parental house for bringing enough dowry, my other family members will arrange a second marriage of my husband and my husband also threatened that he will leave me and whenever I requested my husband to take me to my parental house during the weekends my husband used to beat me mercilessly and also used abusive languages on me and my parents and upon such continuous mental and physical torture by my family and father in-law and their threats I was forced to confine myself in their said house.
9. That subsequently in the month of January, 2018 when I saw some nude pictures of girl along with some vulgar chats into my husband's phone and when I asked about such things to my husband then my husband cover my face with the pillow and tried to strangulate me with an intention to kill me but somehow I managed to escape and got a severe injury on my stomach.
10. That moreover after passing of time I revealed that my husband is in extra marital relationship with a women and when I tried to ask him about his absence my husband got furious and started to beat me and mercilessly, also threatened me and when I objected the same my husband clearly stated that they love each other and they will kill me and will marry with each other.
11. That thereafter in month of September 2018 when I was doing my household work and asked my husband to switch off the machine, my husband without any reason started to abuse me in filthy languages, threw the slipper on me and also spitted on my face and when I protested against these activities and tried to escape then my husband caught hold of my hair, dragged me on the floor and beat me fists and blows mercilessly and broke my front teeth and smashed on my mouth and due this I besmeared with blood and my husband left me in the same conditions.

12. That after that the level of torture by my husband and father in law increase day by day; firstly, the husband in laws beat me by strangulate my neck, by tight my feet, sat in my chest and put the pillow on my face with an intention to kill me due to that effect I lost my sense and my husband spear me considering that I was dead.
13. That I used to tolerate all those heinous torture by my husband and father in law hoping that one day everything will be alright but the level of torture increase day by day as very often without any realm or reason my husband caught hold of my hair and pulled me to the kitchen where he pressed my neck with an intention to kill me and surprisingly my father in law never came to rescue me inspite of hearing of my scream rather my father in law instigate my husband to kill me but somehow I escaped from their hands. Moreover, my husband always used to have forceful sexual intercourse with me by putting me on the fear of death but the true and actual fact is that my husband is an impotent person and incapable of having intercourse hence my husband always threatens me that if I ever reveal this fact to my family members then he will kill me and burn my body.
14. That subsequently when I was willing to conceive and shared the matter with my husband but my husband and above named father in law disagree on the same after that I found that my husband and my father in law became very aggressive also told me they do not want any child and when I protested the same my husband and my father in law started to torture me both physically and mentally and most of the time I was forced to do all house hold works intentionally, and when I wanted to take rest my husband and father in-laws slapped me hardly, and kicked me at my back with an intention to kill so that I am unable to conceive.
15. That due to these continuous mental and physical torture I became ill and I got tremendous pain at my lower abdomen and when I started to bleed on 03.02.2022 my husband and father in-law refused to take to the Doctor.
16. That whenever I and my husband attained any family program either in Kolkata, Ranchi, Siliguri among our family members my husband used to beat me in front of my family members without any realm or reason only to prove that he is the owner of my life and before him I have no status of a wife.
17. That in the month of June 2023 my husband suddenly came the house and called me a prostitute in front of my father in law and pulled my hair dragged on the floor and continuously taunted me for bringing less dowry and also snatched my phone restrained me from talking with anybody else alleged me of having and extra marital affair, used to beat me, have forceful sexual intercourse with me and not even provide sufficient food and other necessities to me.

18. That since January, 2023 I noticed a girl used to come to my husband shop very frequently, who was very friendly with my husband namely **PRASANT PRASAD**, S/O Santosh Prasad, later I came to know that my husband married the said girl keeping me in dark and cheated me in respect of our marital relationship by breaching my trust and when I protested then **PRASANT PRASAD**, S/O Santosh Prasad used to use abusive languages on me and also beat me mercilessly.
19. That I still stayed with my husband bearing all these inhuman tortures of my husband and father in law with the hope that everything will be alright in future but nothing changed, their tortures increased upon me day by day.
20. That I finding no other alternative informed the said matter to my parents and my sister upon hearing about all these incidents rushed to Gangtok and came to see me at my matrimonial house.
21. That thereafter my husband got furious upon seeing my father and sister and started to humiliate them by using abusive languages and beat me in front of them with fist and blows and when I tried to stop him then he got more furious and started to beat me with belt, spitted on my face strangulate me with the belt by keeping his knees over my chest and pressed by nose with the other hand with the intention of killing me and when I lost my sense and subsequently my husband and my father in law throw me in that condition and my father and sister out of matrimonial house.
22. That since then I am living in my parental house and my husband and father in law never ever bother to take any information rather in the month of August 2024, my husband send one copy of agreement duly signed by him for divorce between me and my husband.
23. That after that I came to know that my husband got married to that lady who usually come to the shop of my husband and continue their marital relationship as husband and wife without getting divorce from me which and illegal act punishable in the eye of law.
24. That presently my husband and father in law started to threat over telephone that if I do not give my husband mutual divorce then they will destroy my life and will circulate among my relatives that I am a "BANZ" as I am not being able to conceive.
25. That recently I came to know that my husband **Prasant Prasad** in connivance with my father in father -in-law namely. **Santosh Prasad**, in connivance with matrimonial uncle and aunty of my husband **Hari Jaiswal** and his wife namely **Sangeeta Jaiswal** arrange remarriage of my husband at Siliguri at S.F. ROAD KALI BARI MANDIR, upon hearing the said news I and my family members went to S.F. ROAD KALI BARI MANDIR and I found that my husband remarried with one **KUSHBOO KUMARI**, Daughter of Jai Prakash Prasad of Lall Bazar Mw, Singtam Nagar Panchayat, East Sikkim on **20.02.2025**.

6. That my husband **Prasant Prasad** in connivance with one **JAI PRAKASH PRASAD**, Son of Kedar Prasad of Lall Bazar Mw, Singtam Nagar Panchayat, East Sikkim with **Santosh Prasad**, in connivance with matrimonial uncle and aunty of my husband **Hari Jaiswal** and his wife namely **Sangeeta Jaiswal**, **KUSHBOO KUMARI**, Daughter of Jai Prakash Prasad remarried my husband and destroyed my life.

That at present I am living in very depressed condition and I have become mentally and emotionally ruined due to the above mentioned inhuman, cruel acts and conducts of my husband namely 1. **Prasant Prasad**, father-in-law namely 2. **Santosh Prasad**, in connivance with matrimonial uncle and aunty of my husband 3. **Hari Jaiswal** and his wife namely 4. **Sangeeta Jaiswal**, 5. **JAI PRAKASH PRASAD**, Son of Kedar Prasad 6. **KUSHBOO KUMARI**, Daughter of Jai Prakash Prasad and I am in very much fear that my husband and my father in law may kill me and may remarry the another lady with whom my husband is having the extra marital affair.

I therefore request before your good self to kindly look into the matter and take strict necessary action against my husband namely 1. **Prasant Prasad**, my father in law namely 2. **Santosh Prasad**, presently residing at Sang Bazar, P.O. Sang, P.S. Singtam, Dist. Gantok, in the State of Sikkim the matrimonial uncle and aunty of my husband respectively namely one 3. **Hari Jaiswal** and his wife namely 4. **Sangeeta Jaiswal**, 5. **JAI PRAKASH PRASAD**, Son of Kedar Prasad 6. **KUSHBOO KUMARI**, Daughter of Jai Prakash Prasad as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
