I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do here by lodge this complain empowered by Electricity ACT 2003 (Amendment act 2007) to the effect that Ramesh Roy S/o Late Baleshwar Roy ID: 400873029 KhalaiBaktari, P.O: Matigara Dist Darjeeling, he has committed use of electricity illegally under section 135 (1) (e) and 138 (1) (b) of Electricity ACT 2003 (Amendment act 2007):

On dated 26.03.2025 at 12.00 hr I along with the accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional office, WBSEDCL, 2) Bijay Lakra, DE & S&LP Darjeeling Regional office, WBSEDCL, 3) Bhusan Lama, 4) Pradip Biswas of Customer care Center Matigara have entered the premise of Ramesh Roy S/o Late Baleshwar CON ID: 400873029. During inspection, it has been found that Ramesh Roy has extended electricity to the disconnected premises of late Baleshwar Roy (currently used by Ramesh Roy) Con ID: 412128283 having outstanding dues. Electricity was disconnected for con ID : 412128283 on dated 05.02.2025. Assessed load of electricity illegally enjoyed by him is 0.24 KW. The findings are incorporated in the inspection report prepared by me at the site.

As unauthorized use of electricity was detected, arrangement has removed and the connection has been disconnected after preparing a formal seizure list duly signed by the witnesses and copy of the inspection report and seizure list handed over to Rina Roy W/O Ramesh Roy.

The inspection team left the said premises at 12.45 hr on date.

Therefore it is requested that a case under section 135 (1) (e) & 138(1) (b) for Ramesh Roy consumer ID : 400873029 may please be registered and arrange for its investigation.
