Sir,

I Channeli Devi Kejariwal wife of late Santosh Kumar Kejariwal aged 67 years am the residence of Panchanai Residency, Hari Charan Sarani, w. no 40, Haider Para Siliguri. I want to lodge a complaint against

- ① Rajiv Chachan (9732274615)
- ② Manisha Chachan (8250547363)
- ③ Payal Sakseria (8637813482)
- ④ Komal Paul (9832633425)
- ⑤ Amit Paul (9832622507)
- ⑥ Premlata Sarda (9002891448) and 3 other people about whom I have no information.

Sir, the gang of 10 to 12 people including above mentioned names attacked me at my home on 8.1.2025 at around 2:30 PM yelling at the top of their voice saying your daughter owes us 2 crore and asked me to sell my house and jewellery to pay their amount which I knew nothing about. I was all alone at time and when my neighbours came and tried to help me they threatened them to step back.

Rajiv Chachan then dashed himself to into my home and checked my entire home, threatened me by knife to give him the keys of all the almirah denying which he snatched my bangles from my wrist which valued more than 1 lakh in 2013 and snatched my money bag and took all the money around 10 to 12 thousand from it.

Manisha Chachan, Komal Paul, Premlata Sarda, Payal Sakseria tried to hit me and Amit Paul was making

of it.

After that those people threatened me not to go to the police or else they would kill my children and their family after getting bailed. Komal Paul said that if I go to the police they would cut us into pieces and throw away.

Manisha Chachan and Pooja Sakseria said that they have good contacts in the police station and think thousand times before going to the police.

After 7 PM Rajiv Chachan again came to my home and threatened me again to murder my sons and daughter and their entire family.

Sir I live alone and was really horrified after this incident and felt insulted in my entire society. I was deeply traumatised that they snatched my bangles and money and could do anything to me and my family because of which I fell physically and mentally ill and I got serious that I had to consult the doctor and was under treatment. I again had to consult the doctor on 13-02-2025 because I was deeply traumatised and was unable to come out of it. Therefore I was hesitating to seek help from the Police.

But Rajiv Chachan kept following me and persecute me entire time shouting 'chor ki maa, chor ki maa' whenever I tried moving out of my home and kept threatening since last few days after which I had no other option but to inform the Police regarding the entire matter.

Sir I stay all alone at my residence and am really helpless and request you to help

in this matter, investigating it thoroughly.
I am hopeful that you will take strict action
against them.
