This is to inform you that I Payel Saini, aged about 37 years, wife of Ajay Sir, Saini, resident of Road no. 2, Jyotinagar, ward no. 40 of S.M.C., P.O. Haiderpara, P.S. Bhaktinagar, Dist-Jalpaiguri am law abiding citizen. I beg to state you that around 2 years ago one Ajay Kumar Kahar, son of unknown and his wife Rupa Ramani Kahar both resident of Gitalpara, near bank of India, ward no. 40 of S.M.C., P.O. Haiderpara, P.S. Bhaktinagar, Dist- Jalpaiguri requested me to lend them an amount of Rs. 75,000/- (Rupees seventy five thousand) as they were in desperate need of money for their daughters admission in school. I being their neighbor with kind and clean intentions agreed to help them with their desired amount of money. I then gradually gave away the said amount of money to the said Ajay Kumar Kahar and his wife namely Rupa Ramani Kahar and they further promised me to pay the money back to me within a couple of months. But after a elapse of 3 months, when I requested them to pay my money back they started ignoring me and stated they will pay me within a few days, despite a lapse of prolonged period I did not receive any money so I stated the incident to my family members and they arranged a meeting where the said Ajay Kumar Kahar and his wife namely Rupa Ramani Kahar agreed to pay me my money back in part payments. Although after such verbal mutual agreement a total amount of Rs. 50,000/-(Rupees Fifty thousand) was paid to me in part payments by the aforesaid Ajay Kumar Kahar and his wife namely Rupa Ramani Kahar. That from past few months I have been requesting them to pay my remaining amount of Rs. 25,000/- (Rupees twenty five thousand) as my husband namely Ajay Saini's health is deteriorating and he is undergoing treatment is North Bengal Medical College and Hospital. After telling them my situation they assured me to pay the amount of money today i.e. on 23/03/2025. That today i.e. on 23/03/2025 at around 07.45 pm I along with my few relatives went to the residence of the said Ajay Kumar Kahar, as they promised me to pay the amount of of Rs. 25,000/- (Rupees twenty five thousand) today. After visiting his residence he started to ignore me and was unwilling to pay me my money. Upon requesting the said Ajay Kumar Kahar suddenly got furious and started verbally abusing me with filthy languages, threats and refused to pay me my money and after a

while when I along with my relatives started to convince him to pay me my money he got more furious and dragged me by my hair and started to hit me with kicks and punches in my head, breasts, and stomach, facing such situations I got so shocked I fell to the ground but still the above said Ajay Kumar Kahar continued to hit me and even tore apart my clothes, witnessing such situation my relatives tried to rescue me but the said Ajay Kumar Kahar did not stop and even attacked my relatives and he further threatened us that if we ever asked him for money he shall kill me and shall cause harm to my family. After such incident my relatives took me to Siliguri District Hospital for treatment (documents attached herewith).

That now being helpless and tortured I am writing you this complaint to take appropriate legal actions against the said Ajay Kumar Kahar and his wife Rupa Ramani Kahar and help me in this situation.
