Respected Sir,

I Shri Ghanashyam Garodia (Son of late Gourishankar Garodia) and Smt. Rutna Garodia (Wife of Sri Ghanashyam Garodia) had purchased a part of land from Smt. Sanita Gupta (W/O. Sri. Rajesh Kr. Gupta).

Area acquiring 5 Kuthas, Plot No. 53 (R.S.) 27 (L.R.), Khatian No. 682 (R.S.) 186 (L.R.), Sheet No. 4 (R.S.) 26 (L.R.), TL No. 2, Mouza: Dubgram, P.S. Bhaktinagar, Dist. Jalpaiguri, within ward no. 41 of Siliguri Municipal Corporation, registration done as on 10/02/25.

As of yesterday, dated 25/03/25, we had assigned a local worker to set up a temporary tin shed on our plot to install electric meter. After the shed was set up, a gang of some miscreants from the adjacent left plot came and started threatening my labour and staff that they should run away to save their life and they put a gate lock in our land gate. Today morning, around 5:30 am, again those miscreants brought a bulldozer from the adjacent left plot and broke the complete wall on the left side and also broke the tin shed by trespassing into my property and are trying all their tactics specialized in land grabbing.

As at now, we know the miscreants identity as:

- ① SAIYAB TAUED BARI] Dist: Paschim Burdwan
- ② SAIYAD PARVEZ BARI]
- ③ MOHD TASMIN NASIR KHAN, HOWRAH
- ④ BUBAI SARKAR, SILIGURI.

Since yesterday they are giving threats to me and labourers to run away for life if we are seen anywhere near our property.

Sincerely, I request you sir to kindly look into this matter on urgent basis and take necessary steps against these kind of torture and land grabbing group of people.
