Sub:-Written complaint.

Respected Sir/Madam,

I, Nirmala Mandal, D/o. Late Ashutosh Mandal, R/o. Ashrampara, Panchanan Sarani, Ward No. 14, P.S. Siliguri, Dist. Darjeeling, would like to inform you that I took Lease a Bar cum Restaurant in the Month of January 2025 name **P.S. Bhaktinagar, Dist. Jalpaiguri and style as of Alishan Max, situated at Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri.** It is important to inform you that yesterday i.e. on 25.03.2025 at about 11:30 P.M some persons namely **1. Arbind Singh, S/o. Not Known, 2. Rohit Roy, S/o. Not Known,** R/o. Salugara, Roy Colony, P.S. Bhaktinagar, Dist. Jalpaiguri **along with 12 others** came to my aforesaid Bar cum Restaurant and without any reason started to assaulted my above named relative and my all staffs with an intention to kill them and they assaulted them with the help of Kara (Steel Bangle) and also they using beer bottles, tissue stand, Chairs and due to said reasons my staffs sustained injuries on their body but especially my above named relative sustained more injuries on his face and head and due to assaulted by them my above named relative became unconscious on the spot and with the help of me and other staffs we took him to the Ananda Lok Hospital and he got 2 stitches on the Head and 1 on the Eye brows and thereafter once again we also took him at Siliguri District Hospital and he was also treated there as an indoor patient.

It is pertinent to mention here that at the time of the aforesaid incident they also used slang languages as well as threatened to my other lady staffs and when my other lady staffs tried to protest the same at that time they also assaulted my lady staffs and during that time the aforesaid persons with a malafide intention touched the private parts of my lady staffs and disrobed them (total aforesaid incident captured at the CC tv photage of my restaurant) and when they left the place at that time they told us that if we approach Police then they will kill me on the road. So, no other alternative way I lodge this complaint before you.

Therefore, I request to you be please to drawn your kind attention in respect of my written complaint and take necessary legal steps against them as early as possible.
