at around 9:30 b.m. when my brother namely Ashish Kumar
Ojha went out side of house at a shop then (i) Mukesh Kr. Sah,
(ii) Rakesh Kr. Sah and (iii) Rakesh Kr. Sah, suddenly started abusing
my brother and when my brother protest against the
same then they started hit them when my father and me
along with other female family member went their then they
abused us in filthy language and suddenly Mukesh
hit my father with a sharp weapon (Daw) and Rakesh
hit me with a stick with the intention to kill me
due to this incident me, my father and my brother
got serious injury when my mother protest against them
then Rakesh and his associates to pull the saree of my
wife babli Ojha and thereafter they abusing my mother
and my daughter minor daughter namely Trisha Ojha,
thereafter I take my father and brother at Siliguri
district hospital my got serious injury at his head and
Chest.

Therefore it is praying before you sir kindly
take necessary action against (i) Mukesh K. Sah,
(ii) Rajesh K. Sah and (iii) Rakesh K. Sah and arrest
them and take appropriate action against them.
