In producing herewith one(01) seized blue colour Sonalika Model DI-47 Tractor with Trolley having Registration No. WB 73 F 2089 loaded with river bed materials under proper seizure list.

I, SI Bhiswadeb Barman of Pradhannagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicles having registration No . WB 73 F 2089 to the effect that on today 27.03.2025 during my RT mobile van duty vide MCC No. 602 dated 27.03.2025 vide GDE No 1587 dated 27.03.2025 at around 19.05 hrs I received a specific source information that illegal mining of river beds materials is going on at Panchanai river bed near salbari majua bosty , under Pradhannagar Police Station, Dist. Darjeeling and they will deliver their river bed materials at Darjeeling more for illegal gain. Accordingly, I informed the matter to you and as per your kind order and direction myself along with force proceed towards Salabari Majua bosty , to verify the veracity of the information by Govt. Vehicle.

On the way at around 19.15 hrs I called a professional videographer to came at Majua bosty and at about 19.40 hrs near Majua bosty we noticed that one blue colour Sonalika Model DI-47 Tractor with Trolley having Registration No. WB 73 F 2089 loaded with river bed materials came towards salbari bazaar and I stopped the vehicle but driver managed to fled away from the spot and I found that the vehicle loaded with huge quantity river bed materials. During local enquiry it came to light that the owner and driver of the vehicle illegally mining river bed materials and sell to their deigned customer for their wrongful gain since long. Accordingly, I seized the above mentioned vehicles loaded with illegal river bed materials under proper seizure list from the spot. The entire process of search and seizure was made under the coverage of videography in between 20.05 to 20.15 hrs as per norms of BNSS and brought to Pradhan Nagar PS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the owner and driver of the seized vehicle having registration number WB 73 F 2089 and arrange for its investigation.
