Respected Sir,

I, Dr Mozammil Aqdas, an intern of North Bengal Medical College, hereby want to lodge a FIR against Dr. Sunny Manna and his group for their unruly behavior, verbal abuse, and physical assault on 12/3/2025 at the Principal's office.

On 12/3/25, at approximately 3 pm, I witnessed Dr. Sanny Manna and his group gathered a crowd in front of our principal office, after they entered in the office and using verbally abusive language against on duty Dr. Anupam Nath Gupta, the Dean of Students' Affairs and Acting Principal on that day. They used criminal force to our respected dean of student affairs with intent to outrage her modesty.

Furthermore, Dr. Sanny Manna and his group attempted to damage Dr. Gupta's vehicle by breaking the wiper and tried to stop the vehicle by sitting on the front hood when we tried to help her to escape this situation around 5 pm. When my friends and I tried to protect Dr. Gupta, Dr. Manna and his group assaulted us, both in the Principal's office and in front of the academic building.
