I, Sri Bijay Lakra, D.E., S&LP Wing, Darjeeling Region, WBSEDCL, Siliguri do here by lodge complaint against Shankar Paswan (present user)(Ph No-8436975074), S/o-Lt. Ashin Paswan, Jyotinagar Colony, Near Hanuman Mandir, Bagracoat, Subhashpally, Ward No.-18, Siliguri, Dist-Darjeeling for having committed offence as stated here under.

On 28.03.2025 at about 11:45a.m. acting on a source information I, along with 1) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpura CCC and other officials of WBSEDCL entered the residential premises of Shankar Paswan and inspected service installation, metering installation of Consumer ID 400031916 in the name of SMT. ANAR DEVI PASWAN.. During inspection it was found that Shankar Paswan is using electricity unauthorisedly & illegally by reconnecting the deemed disconnected service line of the metering installation that was disconnected previously on 20.07.2017 due to non-payment of outstanding energy bill. Total Outstanding dues Rs.4645.00 (Rupees four thousand six hundred forty-five only) including the LPSC of Rs. 2990.00 (Rupees two thousand nine hundred ninety only) till the date of 28.03.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Bentec Electricals & Elec Ltd, serial no.- B3797479 Rd-2704 installed against Con Id. 400031916, seized by preparing a formal seizure list duly signed by witnesses.

As Shankar Paswan have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
