Sir,

I, Ranadip Mazumder, S/O:-Late Kalipada Mazumder, AE & Station Manager, Power House CCC , WBSEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that occurred on 27.03.2025 at Dasarath Pally (Near T,B Hospital), District:- Jalpaiguri , which I believe warrants immediate attention and investigation. The incident involved an accident by a Vehicle No:- WB74/BD2065 with 8 Mtr PCC pole of our electrical installations, that caused significant damage to WBSEDCL's property and public safety.

As per information received from the accident site at 2:10 PM, our technical team promptly reached the spot at 2:20 PM. Upon inspection, it was observed that the accident had caused the following damages to our electrical installations:

- One 8-meter PCC pole on the LTOH line was broken.
- 30 meters of LT AB cable were damaged.
- Other electrical installations were also affected.

The total financial losses caused due to this accident are approximately Rs. 16500.00 (Sixteen Thousand Five Hundred) only.

Given the potential risks and significant financial implications, I kindly request you that a FIR be registered regarding this accident against the said Vehicle No:- WB74/BD2065. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSEDCL property.

This is for your kind information and further needful action please as per law.
