Sub: Urgent Request for Deletion of Objectionable Videos & Preventive Action Against Re-uploading .

Respected Sir,

I, Debasree Kundu( 47 years) W/O- Sri Abhijit Kundu, residing at Nimtala, North Bengal University, P.O.- NBU, Dist.- Darjeeling, am writing to bring to your immediate attention a distressing issue regarding the unauthorized and unlawful uploading of objectionable videos containing my photographs on various websites.

Previously, on 23/11/2022, I had lodged an official complaint regarding a similar offense, and an FIR (No. 231/22, dated 23/11/2022) was registered. At that time, with your kind cooperation, all such content was successfully removed from the websites. However, I have now discovered on 14/03/2025 that one of the same videos containing nudity has been re-uploaded on the same platform , violating my fundamental rights and causing immense mental distress.

Legal Grounds for Immediate Action:

As per Indian cyber laws and women's protection statutes, this act constitutes a serious violation of my privacy, dignity, and personal security, and falls under multiple sections of the Information Technology Act, 2000 and Indian Penal Code (IPC), 1860 ( Now BNS)

This act is not only a direct violation of my personal rights and dignity but also a cybercrime that demands strict and urgent legal action.

My Request:

1. Immediate removal and permanent deletion of the videos from the above-listed websites.
2. Tracing and identifying the perpetrator(s) behind this repeated cyber offense.
