Subject- Lodging an F.I.R against unknown person regarding unauthorized storing of highly inflammable articles near the I.O.C.L. Depo.  
Ref: On the basis of a fire occurred at Ray para opposite of I.O.C.L. Depo. On 26.03.2025.

Sir,

This to inform you that on 26th day of March 2025 at about 11.56 P.M. a fire broke out at Ray Para, Opposite I.O.C.L, N.J.P., P.S.- N.J.P. Dist.- Jalpaiguri. A single storied store room surrounded by dwelling house containing highly inflammable articles was involved in fire. Siliguri Fire Station attended the fire and fully extinguished. Charge handed over to I/C Sonam Lama of New Jalpaiguri Police Station. After fully extinguished the fire, it has been found that the owner/ occupier of the said store neither obtained Fire Safety Certificate /Fire Safety License nor kept any type of Fire Safety measures which attracts the violation under section 11C and 12 of the West Bengal Fire Service Act 1950 (with up-to-date amendment).

That area is fully dense with dwelling houses and opposite of I.O.C.L Depo; where a big incident could have happened on that day.

Hence, legal action may be enforced against the unknown owner/ occupier of the illegal store as per law.
