I, Inspector Sonam Lama Inspector -in-Charge of New Jalpaiguri Police Station Siliguri Police Commissionerate, Dist. Jalpaiguri do herby lodged this complaint as suo motu against supporters of DYFI to the effect that on 28.03.2025 from 15:15-16:00hrs, DYFI supporters of NJP PS and from other parts of West-Bengal had assembled unlawfully without proper permission at Siliguri - Jalpaiguri Road and staged Uttarkanya Chalo programme at Kathaltala More near ACP East -II Office under NJP PS. To prevent any hooliganism and vandalism by DYFI supporters, we erected a barricade at Kathaltala More on road leading towards Uttarkanya under NJP Police Station using traffic road barrier, hired bamboos and ropes to restrain them however they forcefully tried to dismantle the barricade made by Police and created a panic and blocked the road causing hindrance to the free -flow of traffic

and pedestrians and also serious patients going towards hospitals.

Police by using loud hailer announced the gathering to be unlawful and asked to disperse on which the gathering became agitated and violent. As the assembly did not pay any heed to the announcement, the Police chased them to disperse, on which they started to pelt stones aiming the Police, C/567 Kaushik Roy of 2nd Battalion RAF had to fire 3 rounds of LR Cell and 2 rounds of Stun Grenade on which no one was injured. The agitators started to pelt stones on the police and in this process the agitators got more violated and started to burst bomb like materials and showed sharp cutting weapons. The Police Force chased them from Kathaltala towards Noukaghat and after reaching Noukaghat the mob retaliated and started to attack the Police Force by hidden weapons and metal rods. On which myself Inspector Sonam Lama and other Police persons namely Inspector Tenzing Lama SPC got severe injuries and had to be immediately shifted to nearby hospital for medical treatment and Lady Police personnel namely 1. LC/1347 Sneha Das 2. LC/1373 Pramila Roy 3. LC/1395 Mithu Barman 4. LC/ 1235 Anita Roy were physically assaulted and manhandled by touching on their objectionable parts of bodies. Later on further reinforcement of police force the agitators fled away.
