Sir,

In producing herewith one arrested accused person namely Subodh Kumar Das-30yrs s/o Lt Deb Narayan Das of Gulab bag, PO Gulab bag, Belouri Mistitola, PS Sadar, Purnia, Bihar (not verified) along with the following seized articles under seizure as per seizure list:

[i] One (01) transparent zipper plastic pouch containing with 264 grams of said to be brown sugar & marked as- **Exhibit-A**.

[ii] One blue colour VIVO -1916 mobile phone having IMEI No-860050049172418 & 860050049172400 with sim No-7765890916 marked as -**Exhibit-B**.

[iii] One Camouflage back pack & marked as **Exhibit-C**

(Note: - SL No-1 & 2 were kept in SL No-3)

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person and one another to the effect that on 29.03.25 at about 18.10hrs, I received a reliable source input that one male person was coming at P.C. Bus Stand with huge quantity of brown Sugar for delivering the same to his designed customers at Siliguri area for his wrongful gain. The matter was diarized in Bhaktinagar PS GD vide Bhaktinagar PS GDE No.1584 dated 29.03.25 and subsequently, I informed the matter to the I/C Bhaktinagar PS, SPC in writing and being directed by him, myself along with ASI Khagen Barman, ASI Dhurbo Mishra, C/374 Debraj Biswas and PS Van officer ASI Sadhan Kumar Roy with his force C/1432 Arup Chandra Biswas and C/977 Inamul Haque Sarkar all of Bhaktinagar PS with investigation kit (envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. left for sevoke road area near P.C Mittal bus stand under Bhaktinagar PS by govt. hired vehicle to verify the veracity of the information vide Bhaktinagar PS GDE no. 1585 dated 29.03.25 and M.C.C No- 1653/25 Dated 29.03.25.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at 18.30 hrs we reached in front of P.C.Mittal Bus Stand, Sevoke road and waiting there, meanwhile I called two independent witnesses namely; (1) Adip Pradhan-41yrs (Ph-8972914597) s/o Tek Bahadur Pradhan of Monpuri busty, ward no-43, PS Bhaktinagar Dist Jalpaiguri (2) Anup Biswakarma-47yrs (Ph-7319088662) s/o Hari Prasad Biswakarma of Monpuri,, ward no-43, PS Bhaktinagar Dist Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. After sometimes we found one suspect was coming from check post side towards P.C Mittal side.

Being identified by my source we detained the above noted person along with One Camouflage back pack which was kept in his Shoulder. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he is carrying and possessing "Brown Sugar" with him. Being identified by source and the information in hand and stated him that he will be searched for the purpose. He admitted that he had illegally possessed brown sugar in his possession for selling the same to his designed customers as per requirement for his wrongful gain.

I then gave an option in writing whether he will willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Gazette Police Officer. Then I informed over telephone to Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station to come at P.C Mittal bus stand near Tower under Bhaktinagar PS requested him to presence during search and seizure of the Brown Sugar.

Accordingly at 20.45 hrs Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision in presence of witnesses the process of search of the detained persons for conducted following all formalities and recovered the above noted articles from the exclusive possession of above noted accused person. Subsequently, being demanded in presence of Shri Amit Adhikary, Inspector In-Charge, Gazetted Police Officer the detained person failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packets with the weighing instrument and found total 264 grams Said to be Brown Sugar which was kept inside in a bag of above noted accused person. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses. I also labeled and sealed all the articles under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and witnesses and accused person. The whole process of search & seizure has been audio & VDO graphed. The whole process of seizure was made in between 20.50hrs to 21.50 hrs.

Then, I arrested the above noted accused person namely Subodh Kumar Das-30yrs s/o Lt Deb Narayan Das of Gulab bag, PO Gulab bag, Belouri Mistitola, PS Sadar, Purnia, Bihar after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest u/s 35 (3) of BNSS.

On interrogation he stated that he procured the seized Brown sugar from Bihar to hand over the same at Siliguri to one Md Rahat s/o Abdul Rajjak of Gandhinagar, ward no-43, Near Milton school PS Bhaktinagar Dist Jalpaiguri both are drug suppliers.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Subodh Kumar Das-30yrs s/o Lt Deb Narayan Das of Gulab bag, PO Gulab bag, Belouri Mistitola, PS Sadar, Purnia, Bihar and Md Rahat s/o Abdul Rajjak of Gandhinagar, ward No-43, Near Milton school PS Bhaktinagar Dist Jalpaiguri both are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Subodh Kumar Das-30yrs s/o Lt Deb Narayan Das of Gulab bag, PO Gulab bag, Belouri Mistitola, PS Sadar,
