In producing herewith the accused person namely Chaman Ali @ Chiku, aged 33 years, s/o- Late Daribuddin @ Darab, resident of Budhugachh, Kuchila, Ramganj, PS- Islampur, Dist- Uttar Dinajpur under custody along with the following seized articles under proper seizure list:-

- (i) One plastic pouch contains brown colour powder like substance suspected to be "brown sugar" measuring weight 102 (one hundred two) grams and marked as Exhibit-A.
 - (ii) One plastic pouch contains brown colour powder like substance suspected to be "brown sugar" measuring weight 103 (one hundred three) grams and marked as Exhibit-B.
 - (iii) One plastic pouch contains brown colour powder like substance suspected to be "brown sugar" measuring weight 103 (one hundred three) grams and marked as Exhibit-C.
 - (iv) One plastic pouch contains brown colour powder like substance suspected to be "brown sugar" measuring weight 97 (ninety-seven) grams and marked as Exhibit-D.
 - (v) One plastic pouch contains brown colour powder like substance suspected to be "brown sugar" measuring weight 102 (one hundred two) grams and marked as Exhibit-E.
 - (vi) One vivo Y16 android mobile phone, Model- V2204, SI. No. 10BCAB053P00071, IMEI No. 865905061182014/40 & 865905061182006/40 and marked as Exhibit-F.
 - (vii) One black colour plastic carry bag in which all 5 packets [SI. No. (i) to (v)] were kept concealed.
 - (viii) Cash Rs. 940/- (nine hundred forty) in the denomination of Rs. 100/- x 9 notes & Rs. 20/- x 2 notes.
 - (ix) EPIC of Chaman Ali vide EPIC No. TQF0814913.
 - (x) One brown colour leather purse styled as "JOOP".
 - (xi) One pendrive (SanDisk 16 GB) contains audio-video record of search, seizure & arrest.

I, SI Debabrata Kundu of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted arrested accused person to the effect that today on 17.03.25 at 17:50 hrs received a specific source input that one suspect had been waiting at Kolkata Road (NH-31) and he had possessed & carried substance suspected to be brown sugar for delivering the same to his designed customers. The matter was diarized vide Bagdogra PS GDE No. 754 dated 17.03.2025 and I informed the matter to the Officer-in-Charge of Bagdogra Police Station, S.P.C. As per his kind direction a raiding team is formed consisting SI Binup Mahato, ASI Munna Ahmed, C/1509 Sourav Roy Sarkar, CV/375 Jogesh Barman & CV/389 Janak Singh, all of Bagdogra PS, S.P.C being headed by me and at 18:05 hrs we left for Kolkata Road (NH-31) under Bagdogra PS by Govt. vehicle No. WB68Q/6401 with investigation kit to verify the veracity of the information in hand vide Bagdogra PS GDE No. 756 dated 17.03.2025 and M.C.C. No. 110/25 dated 17.03.2025. I contacted with the videographer namely Nikhil Sarkar, aged 49 years, s/o- Late Bhupendra Sarkar, resident of Loknath Nagar, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9832028145) to accompany us at Kolkata Road (NH-31) to prepare the audio-video record of the whole process of search and seizure, if any and he also accompanied us. Further, I contacted with two local witnesses namely Anil Singh, aged 41 years, s/o- Late Suraj Singh, resident of Bhujipani, Kolkata Road, PS- Bagdogra, Dist- Darjeeling and Mukund Kr. Jha, aged 40 years, s/o- Late Satya Narayan Jha, resident of Upper Bagdogra, Panighata Road, PS- Bagdogra, Dist- Darjeeling and issued them notice

in writing to remain present with us as independent witness for the purpose of search, seizure, arrest, if any. They expressed their willingness to remain present with us as independent witness. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offenders. At around 18:25 hrs we reached at Kolkata Road (NH-31) near Track Marshal keeping the Govt. vehicle away and made an ambush there. After a while, the source informed that the suspect had been waiting on the service road of NH-31, Kolkata Road near Track Marshal. Then we proceeded towards the place. After reaching to the place we cordoned the place from all directions and being indication by source we apprehended the suspect there at around 18:37 hrs. Source identified the suspect. Then after disclosing our identity, we detained the suspect with a strong reason to believe that he was illegally possessing, carrying and dealing with Brown Sugar in his exclusive possession for selling the same to his designed customers for his wrongful gain. On being asked he revealed his identity as Chaman Ali @ Chiku, aged 32 years, s/o- Late Darbuddin @ Darab, resident of Budhugach, Ramganj, PS- Islampur, Dist- Uttar Dinajpur. At last, he confessed his guilt and admitted that he possessed Brown Sugar and had been waiting there for delivering the same to his designed customers. I then gave him option in writing whether he wanted to be searched in presence of Magistrate or Gazetted Officer. Then he agreed to be searched by any one of them. Further, I served him Notice u/s 50 of NDPS Act in accordance with provisions of law in this regards. Accordingly, I informed the matter to the OC, Bagdogra PS, and then as per his direction, I informed the fact to Shri Debasish Bose, ACP, West-II, SPC regarding the apprehension of one suspect namely Chaman Ali @ Chiku, aged 32 years, s/o- Late Darbuddin @ Darab, resident of Budhugach, Ramganj, PS- Islampur, Dist- Uttar Dinajpur suspected to be possessed with Brown Sugar and requested him to come at the Service Road of NH-31, Kolkata Road near Track Marshal under Bagdogra PS and to supervise the process of search and seizure, if any. Accordingly, at around 19:07 hrs Shri Debasish Bose, ACP, West-II, SPC arrived at the spot to supervise the process of search & seizure, if any. Accordingly, I disclosed his identity to the detained person as the Special Executive Magistrate. I also offered the independent witnesses and the detained person to search our Police Party as per provision of law but they denied searching police party. Then in presence of the Special Executive Magistrate Shri Debasish Bose and two independent witnesses I searched the detained person following all legal formalities and recovered one black colour plastic carry bag concealed inside his wearing apparel (shirt). On opening the black colour plastic carry bag, five plastic pouches containing brown colour powder like substance suspected to be "brown sugar" were recovered. Further, one mobile phone (Vivo Y16), one brown colour leather purse, EPIC and Cash Rs. 940/- were also recovered from his possession. On verification, his identity is revealed as Chaman Ali @ Chiku, aged 33 years, s/o- Late Daribuddin @ Darab, resident of Budhugach, Kuchila, Ramganj, PS- Islampur, Dist- Uttar Dinajpur. He identified the substance as "Brown Sugar". On demand in presence of the Special Executive Magistrate and the independent witnesses he failed to produce any valid document in support of possessing of that substance suspected to be brown sugar which he had carried. Thereafter, I arranged to weigh the recovered plastic pouches containing substance suspected to be Brown Sugar in presence of the Special Executive Magistrate and the independent witnesses with the weighing instrument and found measuring 102, 103, 103, 97 & 102 grams including plastic pouches respectively. On further interrogation, he confessed that he procured the brown sugar clandestinely from Ramganj, Islampur for the purpose of delivery the same to his designed customers at Bagdogra and Siliguri area as per his requirement for his personal gain by illegal means. On interrogation he also disclosed that he has been dealing in such business of selling brown sugar illegally for a long time. Thus when his involvement in carrying, possessing and dealing with brown sugar was established, I seized the above noted recovered articles from his exclusive possession at the spot under proper seizure list in presence of the Special Executive Magistrate as well as the independent witnesses as noted above and acknowledged by the accused person and marked the seized articles as Exhibit-A, B, C, D, E (brown colour powder like substance suspected to be "brown sugar") & Exhibit-F (Vivo Y16 mobile phone). Subsequently, I labeled the seized articles in presence of the Special Executive Magistrate

and the independent witnesses and the accused person as noted above. From the above noted facts and seizure of incriminating articles it is quite evident that the accused person Chaman Ali @ Chiku (as noted above) is involved in procuring, possessing, carrying and dealing with Brown Sugar illegally and contravening the norms of NDPS Act. Then, I arrested the involved accused person Chaman Ali @ Chiku (as noted above) after observing all legal formalities as well as after communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police Officers for possessing & carrying substance suspected to be brown sugar and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 18:37 hrs and 19:48 hrs on 17.03.2025. The process of search, seizure & arrest is done through audio-video electronic means using DSLR camera and then the same audio-video record is converted to a pen drive using computer system.

Under the above noted facts and circumstances, I request to you that a specific case under proper sections of law may kindly be started against the involved arrested accused person namely Chaman Ali @ Chiku, aged 33 years, s/o- Late Daribuddin @ Darab, resident of Budhugachh, Kuchila, Ramganj, PS- Islampur, Dist- Uttar Dinajpur and arrange for its investigation.
