Sri Pankaj Roy, presently residing at Dhansara Jote, P.O. Ranidanga, P.S. Bagdogra, Dist. Darjeeling, inform you that on 25.02.2019 I was married with **SRI PANKAJ ROY**, S/o. Gangadhar Roy, resident of Bhupendra Nagar, Ward No. 42 of S.M.C., Chiharu Jote, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, as per Rites & Customs, soon after our marriage, my husband, mother-in-law and brother-in-law used to torture as mentally and physically as per direction of mother-in-law & father-in-law. My husband has tried to kill by beaten severally and strangled. I have bound to left from my in-laws' house in fear of this death. I was stay only three months in my in-law's house and in the mean while my husband took loans from different private financial funds in my name. Because of I could not repay these loans, my in-laws subjected me to inhuman torture and as a result I took shelter at my parental house and my husband is staying with me by forcibly but my husband does not earn and as a result some disputes arose between me and in some times my husband assaulted me as per direction of my in-laws' and my husband continuously taken money from my father and suddenly he abscond from my present address and my husband continuously threatening me that if my father will not fulfil his demand then he will kill me and by this threat he was always trying to take opportunity to take money from my father. On 14.07.2019 at about 01:00 A.M. he demanded

some money from me and when I have refused to fulfil his demand then he was tried me to strangle to death and also he also wipe away the vermilion from my forehead and he has broken my sakha of my hands and also he denied me that I am his wife and he left my parental house.

Narrating the said fact I have lodged a written complain on 22.07.2019 at Bagdogra Police Station. In the mean time one female child was born on 21.01.2020 and the name our baby as **SWEETY ROY** and thereafter my husband assured me that he will rectify himself and he will restart our conjugal life in my present address and I also did not file any maintenance case at any court of law in a hope that my husband will rectify himself as a good human person, which is the expectation of every Indian Lady but yester my husband came back to my present address and he has behave with me as a good husband but his intention was not good and he tried to kill me through leakage my gas pipe in the absence of my family and also in the absence of my daughter and me and when I have came to kitchen then I have got smell of gas and I have came to know that the gas pipe has been leaked and now he is continuously threatening me and my other relatives that he had tried to kill me by leaked gas pipe but unfortunately I alive and also told me that next time he will kill me, I am very afraid to stay in my present address.

So, I, fervently request you would kindly take a legal step against him and I shall remain ever grateful to you and oblige thereby for your kind action.
