I, Minakshi Das (Ghosh), D/o -
Nipen Ghosh, resident of F.V. Pally,
Sangati More, Ward No-38, Siliguri
writing to report an incident of
property Vandalism that occurred at
my premises, Behar more, Bagdogra
in which I have rented my premises
for fitness Centre "Siyas Fitness
Palace". Yesterday Around 9:00pm
A person namely "Sujit Ghosh"
who is a customer in Unisex Gym
started heated argument with other
gym customers and my tenant
"Shivam Jha". Then after arguments
Sujit Ghosh started threatening, used
abusive words to gym members as well
as to Shivam Jha and threatened with
dire consequences that he will show
us his muscle power.

Suddenly Around 12:45pm few goons under the leadership of Mr. Sujit Ghosh (suspect) threw big boulders and Beer Bottles and broke & vandalised our property (front Glass) and fled away. This is a serious issue of mischief (property vandalism) and a serious concern regarding one's safety.

Thus, I request you to investigate the matter & take appropriate action against the perpetrators. especially "Sujit Ghosh" who is totally involve in this whole matter.
