Sir,

I, the undersigned, Bikash Minj, son of Late Isdor Minj, of Putimari, P.O.- & P.S. Bagdogra, District:- Darjeeling, West Bengal, Pin Code:- 734014 do lodge this complaint as stated in the following :-

1. That, today, 30/03/2025, in between 10.45 to 11.00 a.m. (morning), one Car Maruti (Alto K10) being Registration No. HR43C8168, hit one E-Rickshaw (Toto) from behind and consequently, my son Dipankar Minj, who travelling in the said E-Rickshaw (ToTo) suffered grievous injuries, his right leg has got badly fractured, and another passenger in the said E-Rickshaw also got injured. The said E-Rickshaw (ToTo) was on the left side of the Panighata Road and the said car hit the E-Rickshaw (ToTo) from behind at/near Rittik Cycle Store / Gupta Flour Mill, Panighata Road, Upper Bagdogra, where the accident took place. Due to the said accident the said E-Rickshaw (ToTo) has been badly damaged. The E-Rickshaw (ToTo) was driven by Ajit Lohar s/o Bandhan Lohar of Bhujipani Chhat, Near Kali Mandir, Bagdogra.
2. That the said car was driven in a rash and negligent manner due to which the accident took place.

I therefore request you to take immediate action against the driver of the said Maruti Alto K10 car-and oblige.
