Sir

I, Sri Sudipto Sarkar (51 years), S/O- Lt. Sukhendra Lal Sarkar residing at Sree Maa Sarani, Alu Chowdhury More, Babupara, P.O. & P.S. Siliguri, Dist. Darjeeling hereby lodge a complaint.

On 23.03.2025 at about 10'15 hrs, while I was in my home at Babupara, one Sri Pratap Chandra Nandy, S/O- Late Rashik Lal Nandy of Deshbandhupara, P.O. & P.S. Siliguri, Dist. Darjeeling came to my house and requested me to receive an amount of Rs. 1597/- (Rupees One thousand, Five hundred and Ninety-Seven only) as rent for the shop-room located on the front of my house; but I did not agree to receive the rent from him, upon my utter surprise and dismay, he showed and supplied me a copy of "Deed of Agreement" duly notarised on 04.04.2014 wherein my name was shown as a party of the agreement made between aforesaid Sri Pratap Chandra Nandy and my father (Lt. Sukhendra Lal Sarkar) which included my name and a signature that does not match mine.

On thorough perusal of the said copy of agreement, I discovered that my name was falsely appended to the agreement by Sri Pratap Chandra Nandy. Upon examining the agreement, I was shocked to find that the signature purportedly mine was, in fact, a forged signature, as I have never signed on the said 'agreement' produced by Sri Pratap Chandra Nandy. The said signature of mine is not my signature and I am sure it was made in collusion with and in connivence of said Sri Nandy, which has no basis at all.

It is absolutely evident that Sri Nandy and his cohorts crafted my false signature as part of a larger criminal conspiracy aimed at achieving an ulterior motive.

I have never signed any document in the manner appearing on the agreement produced by Sri Nandy. This fabricated and forged signature is a deliberate attempt to deceive with intent to cause damage to part with my property and commit fraud. Sri Nandy dishonestly, fraudulently forged my signature with intention to misappropriate and cheat, resulting in severe consequences for my property. This signature is nothing but the product of deep-rooted conspiracy from Sri Nandy and others to make out a fabricated documents for the purpose of cheating.

I, therefore, request you to initiate an FIR against Sri Pratap Chandra Nandy and his accomplices for thorough investigation, accumulation of evidence and appropriate legal action.

Please find attached the following documents i) Photocopy of the said "deed of agreement" with my false, fake, forged signature, ii) Photocopy of my Pan Card, wherein my signature is available and iii) Photocopy of one land purchase deed, vide No. Q2001826033/23, wherein my signature is also available

I appreciate your prompt attention to this matter and look forward to justice being served.
