Sir,

In producing herewith one arrested accused namely Ramesh Singh (40), S/o- Ram Sarup Singh of Tumba Jote, Dangi Busty, PO+PS-Matigara Dist- Darjeeling along with seized vehicle bearing Display No. WB 76 2214 loaded with river bed materials along with related documents. I ASI Bikash Roy of Matigara P.S, SPC do hereby lodge a written complaint against the above noted accused person to the effect that on 31.03.2025 received an information from reliable source that one truck loaded with illegal riverbed materials coming towards Tumbajote near West Point School under Matigara PS and the information was diarized at GDE vide Matigara PS GDE No- 1790, Dated- 31.03.2025. On receiving the information I informed the matter to the I/C Matigara PS and as per his kind order myself along with C/219 Sanatan Chitrakar, C/523 Sanjit Kundu and C/868 Sujal Roy rushed to the spot to work out the information. After reaching the spot, at near West Point School I found the said truck bearing Display No. WB 76 2214 is coming towards Tumbajote near West Point School and loaded with river bed materials. Subsequently, I asked the driver to produce valid documents / papers of the said river bed materials, but he failed to produce any valid documents in support of said materials. As such I also seized the above noted loaded truck under proper seizure list in presence of available witnesses and arrested the driver namely Ramesh Singh (40), S/o- Ram Sarup Singh of Tumba Jote, Dangi Busty, PO+PS-Matigara Dist- Darjeeling under proper memo of arrest and brought the above noted vehicle at P.S. The whole seizure process was made under videography and in between 08:05 hrs to 08:15 hrs.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle namely Ramesh Singh (40), S/o- Ram Sarup Singh of Tumba Jote, Dangi Busty, PO+PS- Matigara Dist- Darjeeling and the seized vehicle bearing Display No. WB 76 2214 under proper section of law and arrange for its investigation.
