Respected Sir,

With due respect, I, Madhabi Kumar Lama @ Sur, W/o Sri Kumar Lama, resident at Akshay Tara Apartment, 14/6 2nd Mile, Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, beg to inform you that I am a married lady and my marriage was solemnized with one Kumar Lama, S/O-Lal Bahadur Lama and Lal Maya Lama on 3rd September, 2018 in a Kali Goddess Temple, situated at Malbazar and we started to live together as husband and wife at Indigo Residency, Salugara and out of our wedlock one female child namely Jetsun Sonam Lama was born on 23/02/2021 and she is presently 4 years of age. Son after the marriage, it was found by me that my husband has hidden the fact that he was previously married and also have two kids. Later, my husband went back to his previous residence at Army Double Road, Dakshin Sakoajhora, Gairkata, Sakoajhora, Jalpaiguri, West Bengal- 735212 without any reason and did not return to me and my daughter for 3 months, and due to that on 06/12/2022, I along with my daughter went to the meet with him, where my husband's 1st wife Indu Lama and their son Wangyal Lama and elder sister namely Neera Lama, physically assaulted me brutally and they continued inflicting torture upon me both physically and mentally, which was unbearable for me and even they tried to kill the suckling baby by pressing her neck but somehow I rescued my baby. Thereafter on 23/12/2022, I informed the aforesaid incident to the Inspector-in-Charge Banarhat Police Station, Dist- Jalpaiguri. Further, I have also filed an application U/s 12 of Protection of Women from Domestic violence Act, 2005 with is pending vide Misc Petition Case No. 12 of 2024.

From thereon, my husband namely Kumar Lama & his son namely Wangyal Lama are continuously threatening me to withdraw the aforesaid cases filed against them and even threatening me that if I do not comply with their wish the me and my daughter will face dire consequences.

Unexpectedly on 29/03/2025, at about 8 p.m., which I being alone with my daughter driving & returning to my home and we were at Binnaguri near St. James School, two persons wearing helmet on Royal Enfield Bike (Bullet) approached my car and attempted to force it to stop by pushing it on the road. But somehow understanding their intention, I was scared and quickly drove away, unaware of the fact that they continuously followed me. Later, while I was in between Bengal Safari and Salugara, the said Bike again came and pushed my vehicle on the corner of the road and both the bikers came to my car and removed their helmet. I found that one of the bikers was Wangyal Lama and the other was unknown to me. The said Wangyal Lama came to my window and started decorating me with unspeakable language and even threatened me to immediately withdraw the legal proceeding started against his father i.e. Kumar Lama otherwise he will have no other option other than ending the life of me and my daughter. I being scared and unable to move somehow gathered courage and started my car and ran away from there and returned to our home. I am just scared and worried that at any point of time said Kumar Lama & his son namely Wangyal Lama shall make any attempt to end the life of me and my daughter.

I, therefore, request you to investigate into the matter and please take appropriate legal steps as per the provision of law against Kumar Lama (Ph – 9733026155) & his son namely Wangyal Lama (Ph- 8436358844) and obliged thereby.
