On 29.12.2024, a gentleman named Anirban De, son of Saibal Kumar Dey resident of 15, Horimohan Dutta Road, DumDum, North 24 Parganas, Kolkata- 700028, came to our resort along with his fiancé named Debanjali Chakraborty, daughter of Goutam Chakraborty, resident of 20/13/1, Seal Lane, Tangra, Tangra S.O., Kokkata-700015, alongwith two dogs, one of which was a German Shepard and the other one a Labrador, Ms. Debanjali Chakraborty and Mr. Anirban De since then has been staying at our resort continuously. After few days of their visit, one of the dogs fell ill and thus they had to prolong their stay. Eventually, Mr. Anirban De and Ms. Debanjali Chakraborty told that they have run out of funds and they need to arrange funds to pay the outstanding amount due and payable to the resort. allegedly went to Kolkata. Since then we are coordinating with the same but she has not paid a single penny to us. Till date only an amount of Rs. 73100 was paid initially and thereafter, no payment has been made. For the last one month we have been requesting Mr. Anirban De and Ms. Debanjali Chakraborty to pay the outstanding amount, but no amount has been paid. Instead Mr. Anirban De has been staying in our resort with his two dogs since 29.12.2024 i.e. a total of 93 days and now total due bill is 488970 till 31.03.25.

It is now evident that the culprits Mr. Anirban De and Ms. Debanjali Chakraborty both in connivance with each other, with a preconceived malafide intention to cheat us had induced us to let them use our property having full knowledge that they would not pay for the same.

I therefore request you to kindly investigate the aforesaid matter and book the culprits Mr. Anirban De and Ms. Debanjali Chakraborty in accordance with appropriate provisions of criminal law.
