With due respect I, Akimul Islam S/O
Lt. Abdul Hamid of Salbari, Pura Busty,
P.S.- Pradham Nagar, Dist:- Darjeeling, would like
to inform you that I had bought one shop
situated at Salbari, Near Krishi Bazar, P.S: Pradham
Nagar from the said Md. Nayun Hussain and
I had made a payment of Rs. 10,00,000/- on
September²⁰²⁴ through Cheque Payment of Rs.
5,00,000/- and on December²⁰²⁴ of Rs. 5,00,000/-
and as he was my brother, I trusted him and
he orally made a commitment that he will transfer
the possession in my name within next six months.

On 21/03/2025 at about 12.11 AM. he threatened
me on a phonecall to leave the said shop room
or else he will kill me and on asking back the
money which I had paid, he clearly denied to
return back the money. He also denied to execute
the agreement of the Shop and to transfer the
possession which he had orally made the commitment.

On 01/04/2025 the said person came to
the shop at about 12.00 P.M. and started to threaten
me to leave the shop room and when I refused

to leave the shop room he became violent and started to hit me and also threw stones at my shop and broke the glasses which was kept in my shop and also threatened to kill me using filthy languages and he also took all the cash from the counter of the shop without my knowledge. I, in good faith and relationship had trusted and made the payment of Rs. 10,00,000/- to the said person but he breached the trust and frauded me and when he became violent and hit me, he also hit my mother namely Noorzahan Khatoon and used filthy languages which outraged her modesty in front of the police officer A.S.I. Sanjib Mukherjee. He also threatened her to kill if I don't leave the shop room.
