With due respect, I Shankar Chettry, S/o- Lt. Chandra Bahadur Chettry of Jore Bunglow, Hill Cart Road, PS- Jore Bunglow, Dist- Darjeeling at present C/o- Diwas Dukpa. Patharghata, 1 No. Anchal would like to inform you that I was introduced to one Md. Hafijur Karim, S/o- Lt. Mostafa Kamal of Deara Metiagacha, PS- Rajarhat, Dist- North 24 Parganas through one Sanjib of Debidanga. He identified himself as a reporter, entrepreneur and also influential well known to high dignitaries. He offered me to invest in his various projects for short period which will have return and high dividends. Influenced by his attitude and his false designated representation, I expressed my willingness to invest a sum of Rs. 12,00,000/-(rupees twelve lakes only) in cash as it was told that now banking transaction will be entertained. On 22.03.25, Md Hafijur Karim came to my rented house at Patharghata and took Rs. 12,00,000/- in cash with a promise to return the amount within 05 (five) days. After lapse of 05 days I called him about my money but he was not interesting to listen to me. I tried hard to contact with him but he was avoiding me. On 30.03.2025, I met with him at Airview More and ask about my money. He replied that he will reached at my home very shortly with the money. I trusted him and left him. On the same day at about 19.00 hrs he came to my house in a vehicle having Registration No. WB 20 Z 2221 and gave me Rs. 6,00,000/-. While I asked him for my rest amount of money, he assured me to return the same shortly and left my house. After a lapse of time out of curiosity I examined his vehicle which he left back at my residence and found that there are several identity cards including PAN card in different names with the photographs of Md Hafijur Karim and it is likely to be manufactured illegally.

In these above noted fact and circumstances, kindly take the necessary legal action against the above noted accused person and make me obliged.
