With due respect and humble submission, I, **Raj Ghosh**, Son of Sri. Mithu Ghosh, Resident of Jadab Pally, Ward No.- 7 of Siliguri Municipal Corporation, Post Office - Siliguri Bazar, Police Station - Siliguri, District - Dajeeling, West Bengal - 734005, would like to state you that Sri. Mithu Ghosh, Son of Late Indramohan Ghosh is my father, who used to reside at our aforesaid address and that he used to run a Garage at Khalpara More, Khalpara, Siliguri and yesterday i.e. on dated 31st March, 2025 at around 3 P. M. to 3:30 P. M. when my father was going towards Naya Bazar from his Garage situated at Khalpara More riding his Bi-Cycle.

Suddenly at Naya Bazar, a White Colour Bolero Pick Up Van Goods Carrier Vehicle bearing Registration No.- WB 73 E 7351, which was driven by one Laxman Barman, Son of B. Barman, Resident of Mathabhanga, Cooch Behar (having Mobile No.- 9733380926) was reversing his vehicle very negligently at a high speed and suddenly hit my father from behind who was riding his Bi-Cycle.

Soon my father fell on road and sustained grievous injuries on his head, forehead, neck, face, tooth and also on various parts of the body.

Thereafter, my father was rushed to Sanjeevani Hospital, Ashram Para, Siliguri and the doctors there started the treatment of my father and as a result, my father got 10 Stitches in his head, 4 of his tooth were broken and he has been admitted in ICU of that hospital and undergoing treatment and is in very serious condition till now.

That as all of our family members were busy in looking after my injured father, none could turn up immediately to your concerned Police Station immediately after the incident and that today I am lodging this Written Complaint / F. I. R. before your good self.

That Sir, since then I and my family members are very much worried and tensed about the situation and health condition of my father and we all are in deep trauma and fear has insisted upon us due to such incident and that we are very helpless to help ourselves, except seeking your kind co-operation and support.


