I, the undersigned, wish to bring to your notice an incident of reckless and negligent driving that took place on 01/04/2025 at around 7:30 AM near P&T Colony, Jalpaiguri More, Police station - Siliguri, District Darjeeling.

While I was passing through the said location, I observed that a yellow-colored school bus belonging to the Eichar company, bearing registration number WB73E3100, was in a hazardous condition. The rear wheel of the bus was misplaced, causing a potential threat to public safety. Additionally, I noticed that an individual was lying injured near the bus.


