In producing herewith the following five accused persons namely (i) Sunny Thapa (33 yrs) S/O Gopal Thapa of Middle Palash, Debidanga, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling (ii) Don Roy (22 yrs) S/O Budu Roy of Samar Nagar, Battala, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling (iii) Tanmoy Roy (33 yrs) S/O Late Tapan Kr Roy of Mallaguri near Kali Mandir, PO+PS- Pradhan Nagar, Dist. Darjeeling (iv) Jaydeep Debnath (40 yrs) S/O Late Ranjit Debnath of Dhaknikata, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling and (v) Bikram Sarkar (41 yrs) S/O Late Gour Chandra Sarkar of Ujanu Shib Nagar, near Darjeeling More, PS- Matigara, Dist. Darjeeling under arrest and the following articles under proper seizure list viz :- (i) One Motor Cycle bearing Registration number WB/79/A/3645 (Scooty) (ii) One Motor Cycle bearing Registration number WB/74/BF/9489 (Scooty) and (iii) One Motor Cycle bearing Registration number WB/74/AR/2182,I, ASI Biplab Kr Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted five (05) arrested accused persons and others 03/04 unknown miscreants who are involved in this crime to the effect that on 02.04.25 at 00.15 hrs, myself along with force left PS to perform night PC Mobile van duty vide Pradhan Nagar PS GDE No 55 dated 02.04.25. In course of my duty at around 02.25 hrs I received a specific source information that 08/09 miscreantsequipped with deadly weapons assembled at near Narmada Bagan, Champasari Main Road under PS- Pradhan Nagar and they are making preparation for committing dacoity on cars and vehicles plying on Champasari/Milan More road. Accordingly, I informed the fact to you over Mobile Phone and being directed by myself along with force had been to Champasari/Milan More Main Road near Narmada Bagan under PS- Pradhan Nagar, Dist. Darjeeling. At around 02.35hrs we arrived atChampasari Main Road near Narmada Bagan and I contacted with my source and from a considerable distance he pointed the place where the miscreants assembled. Then we proceeded toward the place and from a considerable distance we noticed that 08/09 persons assembled on the road and a good numbers of vehicles are stranded in both sidesof the road. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted 05 (five) accused persons while 03/04 others unknown miscreants managed to flee away from the spot throwing their weapons of offence in nearby bushes.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such dead hour of night. Finally they confessed that they along with 03/04 of their associates assembled there with an objective to commit dacoity on cars and vehicles plying on Champasari/Milan More road to loot money and other valuable properties. On further interrogation they disclosed that on 01.04.25 evening they chalked out a plan to commit dacoity on car and vehicles on Champasari/Milan More main road and as per their plan on 02.04.25 at around 02.15 hrs they came there riding on their Motor Cycles. But seeing the police personnel they tried to fled away from the spot and also disclosed that they threw their weapons in nearby river and bushes. I searched every possible place to find out the weapon of offence but in vain due to darkness. Accordingly, I seized the above mentioned Motor Cycles from their possessions under proper seizure list in between 02.50 hrs to 03.05 hrs under the coverage of videography in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest and brought all the five (05) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further necessary action.

From the above noted facts and seizure of incriminating articles there is a strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit Dacoity on cars and vehicles plying on Champasari/Milan More road.

Under the above circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the above noted five (05) accused persons namely (i) Sunny Thapa (33 yrs) S/O Gopal Thapa of Middle Palash, Debidanga, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling (ii) Don Roy (22 yrs) S/O Budu Roy of Samar Nagar, Battala, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling (iii) Tanmoy Roy (33 yrs) S/O Late Tapan Kr Roy of Mallaguri near Kali Mandir, PO+ps- Pradhan Nagar, Dist. Darjeeling (iv) Jaydeep Debnath (40 yrs) S/O Late Ranjit Debnath of Dhaknikata, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling and (v) Bikram Sarkar (41 yrs) S/O Late Gour Chandra Sarkar of UjanuShib Nagar, near Darjeeling More, PS- Matigara, Dist. Darjeeling and others 03/04 unknown miscreants and its investigation may kindly be arranged.
