Respected Sir/ Madam,

I, Achal Rai, daughter of Lt. Suk Bahadur Rai
residing at Champasari, Bartalla, I wish to
formally lodge a complaint regarding my
husband Aashutosh Giri who has taken our
daughters Aira Rai Giri, DOB: 20/09/2022, to
Nepal without my knowledge or consent.

For many years, I have been facing issues
in my marital life. On February 3rd, 2024,
when I expressed my intention to seek a
divorce, my husband ran away, taking my
2.5 years old daughter without my consent. I
immediately approached the police station
on the same date to file a General Diary
(GD), but my request was not accepted on
the grounds that it was a matter between
husband and wife.

Again, on February 5th, 2024, I attempted
to file a GD regarding the same issue,
but it was again not accepted. It has
