Subject: FIR.

Sir,

With due respect, I am producing herewith the accused person namely Baliram Singh (30 yrs) S/O Akalu Singh of Tumbajote PS Matigara, Dist.- Darjeeling under arrest and the following articles under seizure viz :- One pick up van having Registration number WB76B 1488 loaded with 03 (Three) numbers of Cattle (Buffalo) with 03 (three) numbers of calves in different size and black in colour. In this regard I ASI Sanjit Mondal of Pradhan Nagar PS, Siliguri Police Commissionerate beg to state that on 03.04.2025 during my night RT mobile duty vide Pradhan Nagar PS MCC No. 651/25 Dated 02.04.2025, I received source information that one vehicle (Pick Up van) having registration number WB76B 1488 loaded with stolen cattle which were procured by stolen or fraudulent means was coming from Bagdogra side. Accordingly, I informed the fact to you over telephone and as per your kind direction myself along with force started to Naka Checking at NH 10 in front of Exit gate of Regulated market under PS Pradhan Nagar, Dist.- Darjeeling in order to intercept the said vehicle. At around 01.20 hrs we managed to intercept the above mentioned vehicle. On verification we found one person in is seating inside vehicle No WB76B 1488. On interrogation he disclosed his identity as noted above. On physical verification it is found that total 03(Three) numbers Cattle (Buffalo) with 03 (three) numbers of calves in different age, size and Black in colour loaded in the said vehicle. On demand the driver of the said vehicle failed to produce any valid documents in respect of the cattle and calves loaded in his vehicle. On demand he failed to produce any permit for carrying livestock in the vehicle and also failed to produce any medical check-up certificate in respect of such Cattle (Buffalo)/calf which is a mandatory provision of law before transporting of cattle (Buffalo)/calf. I also asked him to produce any supporting documents in respect of carrying/transporting the Cattle (Buffalo)/calf of any but he failed to produce the same. During physical verification, it was found that the cattle (Buffalo)/calves were loaded in such a manner which caused unnecessary pain and suffering to those Buffalo/calf as there was no reasonable space/opportunity for their movement. During further interrogation he admitted that Cattle (Buffalo)/calf were procured by illegal means from Bihar side in order to supply the same to Assam to make huge profit.

I, then seized the above noted vehicle having registration number Registration number WB76B 1488 loaded with 03 (Three) numbers of Cattle(Buffalo) with 03 (three) numbers of calf in different size and black colour under proper seizure list in presence witnesses under the coverage of videography as per norms of BNSS and subsequently arrested him under proper memo of arrest and observing all the formalities of arrest and stating ground of arrest for possessing and transporting the Cattle (Buffalo)/calf which is reasonably believed to be stolen property and for causing unnecessary pain and suffering to the Cattle (Buffalo)/calf. The search and seizure made in between 01:30hrs and 01:45 hrs.

Therefore, I request you that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person namely Baliram Singh (30 yrs) S/O Akalu Singh of Tumbajote PS Matigara, Dist.- Darjeeling and arrange for its investigation.
