In producing herewith following five arrested accused persons namely 1) Lakshmon Rauth (29years) S/O Dasarath Rauth of Amtala Shrastinagar ward no 41, PS Bhaktinagar Dist Jalpaiguri. 2) Sadhan Sarkar (31 years) S/O Lt Ananda Sarkar of Amatala Shrastinagar ward no 41, PS Bhaktinagar Dist Jalpaiguri. 3) Bappa Roy (32years) S/O Majen Roy of Baikuntapally, ward no 41, PS Bhaktinagar Dist Jalpaiguri. 4) Manish Gajmer (26years) S/O Gyanu Gajmer of Salugara Bazar, PS Bhaktinagar Dist Jalpaiguri.5) Rabi Pradhan @ Raghu (38years) S/O lt Kalu Pradhan of Chota Fapri, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

1) One iron made hammer alongwith butt measuring approx 12 inches recovered from the conscious possession of Lakshmon Rauth.

2) One curve iron blade length approx 17 inches recovered from the conscious

possession of Rabi Pradhan @ Raghu.

3) One iron made curve blade approx 12 inches recovered from the conscious possession of Manish Gajmer.

4) One iron made screw driver length approx 14 inches recovered from the conscious

possession of Sadhan Sarkar.

5) One iron made wrench approx 8 inches recovered from the conscious possession of Bappa Roy.

I, SI Youel lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted and 5/6 others to the effect that on 02.04.2025 at 00:10 hrs received a specific source information that 10/11 miscreants have assembled at Hiderpara Market complex under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 50/25 dated 02.04.2025 and as per order I along with SI Srimanta Chatterjee, ASI Khagen Barman, ASI Dhurva Mishra, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Hiderpara Market complex under Bhakti Nagar PS, to work out the information in hand.

At about 00.35 hrs we arrived at Hiderpara Market complex under Bhakti Nagar PS, as indicated by the source we noticed that 10/11 persons assembled at Hiderpara Market complex under Bhakti Nagar PS and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 05(five) of them with deadly weapons in their possession but 5/6 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 02.04.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio visual record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 05 (five) arrested accused persons and others kindly arrange for its investigation.
