He is going to exfiltrate towards BD . Before crossing the border he is caught by the BSF team and CIB 33 team of 02 pers at about 1545 hrs .Further he is brought to the BOP Fulbari where he was kept in presence of guard with comdr





0. Brief details of the case

On Dated 02.04.25 AT about 1530 hrs HC/G Regt No. 970091813 HC/G Irappa Lamani received a specific info regarding a suspicious BD National at the village Jhutiakali with likely chances to exfiltrate. The information was further verified and confirmed by CIB official present in that area.

Based up on the information Sh. Sunil kumar AC, 'C' coy Comdr A/W No 896446681 ASI Mangla Ram, No 213200057 CT Dipankar Das, and no 060025854 CT/DVR Amit Kumar Singh and performing the duty of 'G' rap at BOP Fulbari reached village Jhutiakali Where 02 CIB officials are waiting for the BSF team. The suspect was detected at about 1545 hrs and the team nabbed the suspect and brought him to BOP Fulbari.

Initially during PQR suspect produced forged documents and claimed to be indian. However on details questioning and checked of individual BD documents were retrieved from his possession where in it is found that his name is Md. Moksadul Islam S/O Md. Sadekul Islam and he is a R/O Village :Lanlgolgaon, PS :Panchagarh Sadar, Dist : PanchagarhPo: 5000 Bangladesh and. Details questioning of individual was carried out by CIB officials in presence of FGT SHQ SLG.and 18 BN BSF. Up to 021830 hrs in presence of FGT SHQ SLG and G rep of 18 BN BSF and his mobile was also in control of CIB team for collecting information. In the questioning the apprehended also told about the Mr Harun S/O Mustan , Age 32 years vill-Sardarpara near BOP Jummagach ,Mob no 8972178595 who would have help to exfiltrate by the fence.He also called him & recovered the mob no from his mobile.
