## 0. Brief details of the case

In the questioning the apprehended also told about the Mr Harun S/O Mustan , Age 32 years vill-Sardarpara near BOP Jummagach ,Mob no 8972178595 who would have help to exfiltrate by the fence.He also called him & recovered the mob no from his mobile.
