Dist Dajeeing would like to inform you that today
i.e., on 4/4/2025 at about 12:00 pm when my
son namely Md. Rohit was moving along with his
TOTO at Khalpara Road at that time some person
namely 1) Mishal S/O not known 2) Md. Jannat S/O
Md. Kanta along with 4-5 person restrained my
son and demanded whole day collection amount
from my son which was earned by my son from
his TOTO when my son denied to give any amount
to them at that time all of them without any
reason started to assaulted my son with the
help of some sharp cutting weapon like set and
bamboo and due to assaulted by that weapons
my son sustained multiple injuries on his body
specially his head and my son also unconscious
due to assaulted by them and taking advantage of

the same all of them took away the total collection amount of ₹ 3000/- and also took away gold chain from his neck and they assaulted my son with a clear intention to kill him and after the aforesaid intention some known people of me over telephone inform the whole incident and thereafter I rushed on the spot immediately and went to the house of the aforesaid persons and informed the whole incident but at that time also the aforesaid person including their parents and relatives also attack upon me and without any reason the aforesaid person along with their parents and relatives started to assaulted me with fist and blows and during the aforesaid incident the male persons intentionally touch my body parts and disrobe me in presence of other people and they also took away nose pin of gold.

It is pertinent to mention here that due to assaulted by them my son right now admitted at Siliguri Sadar Hospital as an indoor patient and fighting with his life. So finally I lodged this complaint before you.

Therefore I request you to please take necessary legal action against them as early as possible
