Sub: Written F.I.R against my husband and his relatives.

Respected Madam/Sir,

I SMT KIRAN SARKAR, Daughter of Debraj Sarkar and Wife of Birender Singh, presently residing at my parental house at Junction Gate Bazar, Police Station Pradhan Nagar, District Darjeeling do hereby lodge this written F.I.R., to the effect stating that I got married with Sri Birender Singh, Son of Dharamdeo Singh, resident of Bandri Jote, back side of Savin Kingdom, Police Station Pradhan Nagar, District Darjeeling and the marriage was solemnized on 28.04.2013 at my parental house situated at Junction Gate Bazar, Police Station Pradhan Nagar, District Darjeeling.

After my marriage I started living with my husband and his relatives (1) Dharamdeo Singh (Sasur), (2) Smt Lila Devi (Sasuri) and married sister in law Priyanka Singh (Nanad) at my matrimonial house. At the time of marriage as per the demand of dowry of my husband and his relatives my parent gave several household items, gold jewellery and cash of Rs 2,00,000/- (Rupees Two Lacs) only. From the beginning I was subjected to physical and mental torture by my husband and all his relatives for bringing more cash of Rs 1,00,000/-. As my parent is not having sufficient money my parent could not pay further demand amount of Rs 1,00,000/- and due to such reason my husband and his relatives were not happy with me and regularly creating pressure upon me to meet this cash demand or leave the matrimonial house and go to my parental house. For my happiness my parent borrowed money from several other person and in a gap of several months my parent somehow paid this amount to my husband in presence of his relatives. In the course of marriage I gave birth to female child named Smita Singh, aged about 11 years, presently studying in class 5 and male child named Krishna Singh, aged about 10 years, presently studying in class 4. For my happiness, my minor children happiness as well as happiness of my husband and his relatives I used to bear the mental and physical torture and somehow passed 10 years of married life.

Since the month of November 2023 my husband started behaving with me and the children in very rough manner. My husband used to regularly threat me to leave the matrimonial house and go to my parental house along with the two children stating that he does not want to stay with me as he does not like my physical appearance and my skin complexion and that if I does not go to my parental house then he would forcefully drive me out of matrimonial house. Despite hearing such bitter and rough version and

threat of pushing me out of matrimonial house I used to bear his version and threat. I also informed this to his relatives but his relatives never supported me and all the three relatives would say me to listen to what my husband says and want otherwise they will support my husband and support him and they will actively take part in driving me out of the matrimonial house. I was in total helpless situation at my matrimonial house.

In the meantime in December 2023 I suffered from disease of gall bladder stone as well as pain in my heart and my husband and his three relatives refused to give me money for operation and treatment and instead asked me to go to my parent house and do the treatment. For treatment of my heart pain and gall bladder stone I was forced to leave my matrimonial house with the two children leaving my belongings at the matrimonial house. It took long months for treatment and during this period neither my husband or his relatives enquired about my operation of gall bladder and or heart problem and how is the treatment done and continuing. After getting well I called my husband to come and take me and the two children but he refused to take me and the two children and further asked me not to come to the matrimonial house and further and if I come then he would kill me. Even about this threat I informed to his relatives and even they threatened me not to come back or they will do all thing possible to send me back and if necessary they will also kill me. My husband and his relatives conspired among themselves so that I do not come to my matrimonial house. I understood that as the married sister of my husband is staying at the house so they do not want me to return.

I waited for further few months thinking that may be situation will change but they did not change their nature and thinking and kept avoiding me and sometimes they used to block my phone calls to avoid talking to me. Finding no option on 02.04.2025 at about 12.00 P.M I came to my matrimonial house to start living with my husband and his relatives. Just as I entered the house I saw that my husband is staying with another woman named Guddi Sharma, resident of next house of my husband and when I asked my husband as to why he is staying with this woman at my room both my husband and Guddi Sharma said that they are in relationship of husband and wife since past six months and accepted by the relatives of my husband. When I objected about such relationship then my husband, his three relatives and Guddi Sharmabrutally assaulted me by hand and fits as well as wooden lathi and rods. Due to such injury I got severe injury in my stomach and I started vomiting as well as stretch mark on left side of face and nasal bleeding. Moreover I became senseless and left outside by my husband and all three relatives. Some local residents came to my help and they made me gain sense after hours and they send me to my parental house. Being so badly injured I could not make any movement and remained in bed for the rest of the days and night on pain killer tablets. Yesterday on 03.04.2025 at 7.30 A.M my husband came to my parental house and dragged me out and took me with him at his house without saying anything. My mother and my Bhabhi Neha Sarkar sensing some new trouble and injury to me followed

me and when we reached the house again my husband and my nanad Priyanka Singh brutally caused injury to my mother Jhunu Sarkar and to my bhabhi. My bhabhi got injury in her left hand little finger due to hit caused by iron rod. Finally all three of us fled from the matrimonial house as we feared that there is plan to kill me so that my husband can live in relationship with Guddi Sharma for the rest of his life.

Then I went to Siliguri District Hospital for proper treatment and after checking the doctor prescribed medicines and advised test of CT Scan of head. In the above premises I request you to kindly register the written F.I.R., and take immediate legal action against my husband, his three relatives namely Dharamdeo Singh, Lila Devi, Priyanka Singh and Guddi Sharma.


