Subject: Complaint Regarding Theft of Air Conditioner Outer Pipe

I, Sri Souvik Das, the showroom in-charge of West Bengal Handicrafts Development Corporation Ltd. (MANJUSHA) along with Banglar Saree located at L-5 Building, Pradhan Nagar, Siliguri, West Bengal, Pin - 734003, would like to lodge a complaint regarding the theft of the outer pipe of our showroom air conditioning unit. The incident occurred on 05.04.2025 and I would like to bring it to your attention for appropriate investigation and action.

Details of the incident are as follows:

- **Address of the incident:** L-5 Building, Pradhan Nagar, Siliguri, West Bengal, Pin - 734003
- **Date and time of theft:** 05.04.2025 and 03:12 AM
- **Description of the stolen property:** The outer pipe of our showroom air conditioner, which connects the indoor and outdoor units, was stolen. The air conditioner is a Panasonic AC installed on the roof.
- **Value of the stolen property:** Approximately Rupees Ten Thousand.

I have checked the area, and it appears that the thief might have used some tools to remove the pipe, which was securely attached to the outdoor unit. The theft was observed at 3:12 AM on the footage of our showroom's CCTV camera and contacted you for assistance.

I request you to kindly investigate the matter and take necessary action to identify and apprehend the person responsible for the theft.

Please let me know if any further information or documents are required. I would appreciate your prompt attention to this matter.
